Please find attached an ongoing disclosure notice for Gentrack Group Limited (NZX/ASX: GTK).

Gentrack adopted a Senior Management Long Term Incentive Scheme (Senior Management LTI Scheme) by Board resolution dated 27 April 2016. The Gentrack Managing Director, Gary Miles, was issued 187,191 ordinary shares as part of his remuneration under the Senior Management LTI Scheme with a vesting date of 29 November 2023. On the issue of these shares a tax liability was triggered, accordingly a corresponding amount of shares (87,980) was sold on market to cover the expected tax liability. Mr Miles retains 1,085,890 vested shares in Gentrack and other performance rights previously disclosed.
