Dear Eligible Shareholder,

PRO-RATA NON-RENOUNCEABLE ENTITLEMENT ISSUE

On behalf of the Directors of Memphasys Limited (ASX: MEM) ("MEM" or the "Company"), I am pleased to invite you to participate in MEM's recently announced pro-rata non-renounceable entitlement offer of two (2) fully paid ordinary shares (Share) for every nine (9) Shares held by those eligible shareholders registered at the record date of Friday 8 December 2023 (Record Date) at an issue price of \$0.01 per Share (Offer) together with one (1) free New Option for every two (2) Shares applied for and issued, to raise up to approximately \$2,132,268 (Offer).

The Company lodged a prospectus containing the Offer with ASIC and ASX on 4 December 2023 (**Prospectus**) which can be accessed at www.lnvestorServe.com.au and on the Company's website.

All proceeds raised under the Offer will be applied as set out in Section 3.1 of the Prospectus ('Purpose of the Entitlement Offer').

Following completion of the Offer, assuming any shortfall is subsequently placed, and the full subscription is raised, the Company will have issued approximately 213,226,752 Shares, which in addition to the 210,000,000 Placement Shares issued on 11 December 2023, will result in 1,382,747,134 total Shares on issue to raise up to approximately \$4.23 million.

Participation in Offer

The Offer is being made to all eligible shareholders of the Company named on its register of members at 5:00pm (AEST) on Friday 8 December 2023, whose registered address is in Australia or New Zealand (Eligible Shareholders). You have been deemed to be an Eligible Shareholder for the purposes of the Offer. The Offer opens on Wednesday 13 December 2023 and is expected to close at 5.00pm (AEDT) on Tuesday 2 January 2024 (unless extended) as set out in the Prospectus.

The number of Shares for which you are entitled to apply for under the Offer (**Entitlement**) is shown on your personalised Entitlement and Acceptance Form which, along with the Prospectus, is accessible at www.lnvestorServe.com.au. Your acceptance must not exceed your Entitlement as shown on that form. If it does, your acceptance will be deemed to be for the maximum Entitlement.

Ineligible shareholders

A Shareholder who has a registered address outside Australia and New Zealand (Ineligible Shareholder) will not be eligible to participate in the Offer.

You are not eligible to participate in the Entitlement Offer and you will not be sent a copy of the Prospectus. This decision has been made pursuant to Listing Rule 7.7.1(a) of the ASX Listing Rules after taking into consideration the costs of complying with legal and regulatory requirements in

jurisdictions outside of Australia and New Zealand compared with the small number of Ineligible Shareholders and the number and value of Shares to which they would otherwise be entitled
