Unless the context otherwise requires, terms defined in this Seventh Supplementary Bidder's Statement have the same meaning as in the Original Bidder's Statement. This Seventh Supplementary Bidder's Statement is dated 9 January 2024 and was lodged with ASIC and given to ASX on that date. Neither ASIC, nor the ASX, nor any of their respective officers takes any responsibility for the content of this Seventh Supplementary Bidder's Statement.

#### 2 Consents and approval

As permitted by ASIC Corporations (Takeover Bids) Instrument 2023/683, this Seventh Supplementary Bidder's Statement contains statements which are made by Whispir, or based on statements made by Whispir, in documents lodged with ASIC or given to the operator of a prescribed financial market in compliance with the listing rules of the prescribed financial market (including the ASX). Pursuant to that Instrument, the consent of Whispir to which such statements are attributed is not required for the inclusion of these statements in this Seventh Supplementary Bidder's Statement. Whispir Shareholders are entitled to obtain from Soprano within 2 Business Days of request and free of charge any document which contains such a statement. Soprano Design Technology (Australia) Pty Ltd (**Soprano DTA**) is making a takeover bid for all the shares in Whispir Limited (ASX:WSP) (**Whispir**) (the **Offer**).

- 4. tick the box "I'm not a robot" and then select "Next"
- 5. complete the prompts to set up your username and password details
- 6. once you are logged in, select "Offers" from the left-hand vertical menu and follow the prompts

Alternatively, if your Shares are registered in a CHESS holding (such holdings will be evidenced by your Holder Identification Number commencing with an 'X'), you can accept the Offer by instructing your Controlling Participant (normally your broker) to accept the Offer on your behalf, before the Closing Date.
