**Quarterly Activity Report and Appendix 4C  
Quarter Ended 31 December 2023**

**Traffic Technologies Ltd** (ASX: TTI) ('Traffic Technologies' or the 'Company') is pleased to provide its Quarterly Activity Report and Appendix 4C Cash Flow Statement for the quarter ended 31 December 2023.

**Highlights**

- Net operating inflows were \$2.3m in the quarter.
- Debt repayments were \$1.9m in the quarter and \$2.9m over the first six months of FY24.
- Contracts increased over 4% in the quarter.
- Order book is strong with term contracts visibility greater than 5 years.
- Outlook strong despite reduced operating revenue for the quarter.
- The Profit Improvement Program is delivering upon expectations in the quarter with a positive impact with an estimated saving of up to a \$2.5m for FY24.
- Consolidation of buildings and manufacturing commenced with immediate positive impact in the quarter.

**Trading Update**

First half revenue of \$21.2m was down 34% on the previous corresponding period. Operating revenue for the first half has been significantly affected by challenging supply chain issues, government delays on projects and capital constraints within the Company's existing working capital facilities. The outlook is however promising, with a strong order book and term contracts with visibility greater than 5 years up 4%.

Contracts and order wins were positive in the quarter with the Company winning a major tender to supply LED lighting across the Mornington Peninsula in Victoria. Demand for the Company's products and services is well placed, with the increased infrastructure expenditure plans of government and municipal councils, due to our position as the largest, most established and proactively innovative traffic solutions provider in Australia.

The Company has developed a Profit Improvement Program to reduce the Company's cost base and consolidate the operating footprint of its activities. The consolidation of properties occupied by the Company and the reorganisation of manufacturing has commenced and started to deliver a positive impact in the quarter, with savings estimated to be up to \$2.5m through FY24.

The expansion into the Intelligent Transport sector has given the Company the ability to supply sophisticated “Smart City” ready electronics and software across Australia, whilst bolstering the Company’s signage business which provides access to councils, road authorities and contractors across the country. The additional capability within the Company to undertake installation and maintenance work has opened new channels to market for our IoT devices and traffic management products and services.

The Company expects to release its half year results to the market in late February 2024, following completion of the half year audit review.

## **Cash**

December quarter (Q2) cash and deposits were \$1.5m, including pre-payments of \$0.4m in advance to overseas suppliers.

Net operating cash inflow was \$2.3m for the quarter (Q2). Receipts from customers for the quarter were \$11.8m. Cash flow continues to be impacted by the need to prepay overseas suppliers to secure priority in componentry and logistic deliveries to ensure the Company can meet these and other major customer delivery requirements.

Net investing cash outflow was \$0.5m for the quarter, including investment to expand and develop the Company’s Smart City software and product portfolio.

Net financing cash outflow was \$1.9m for the quarter, comprising net repayment of borrowings.
