Webb Street Capital (Subscriber) has provided professional services to Orion in South Africa over a number of years including in connection with Orion's placement announced in March 2023 (Services). In addition, the Subscriber granted a put option to Orion to allow Orion to require the subscriber to subscribe for up to an additional 118,611,109 shares in Orion at an issue price of ZAR20 cents per Share (Put Option). The subscription price (if any) may be set off against further fees (if any) payable by Orion to the subscriber under the Services engagement. Orion has exercised the Put Option requiring the subscriber to subscribe for 1,250,000 shares in Orion at an issue price of ZAR20 cents (AUD17 cents) per Share, with the subscription price set-off against fees owed by Orion to the subscriber for the Services.
