#### **RE: TRADING HALT REQUEST – BLUECHIP LIMITED**

Pursuant to Listing Rule 17.1, Bluechiip Limited (ASX: BCT) (**Company**) hereby requests a trading halt effective pre-open on Thursday, 1 February 2024.

The trading halt is requested pending an announcement to the market in connection with a capital raising program.
