Dear Pact shareholder,

Pact Group Holdings (ASX: PGH, Pact)

I am writing to you as Chair of Pact's Independent Board Committee (IBC).

Since my most recent letter to Pact shareholders on 6 February 2024, Bennamon Industries Pty Ltd (**Bennamon**) has increased its shareholding in Pact to almost 86.9%¹ and has advised that, should its relevant interest reach 90%, it intends to compulsorily acquire all of the Pact shares it does not own.

The IBC continues to recommend that minority shareholders accept the offer of \$0.84 per Pact share (**Revised Offer**) for the reasons outlined in my most recent letter to Pact shareholders. Pact's share price has recently traded on ASX above \$0.84 per share. If that persists, shareholders may need to carefully consider if selling on market (after brokerage and other costs) might achieve a better outcome than accepting the Revised Offer of \$0.84 per Pact share.

How to accept the Revised Offer

Bennamon has extended the closing date of the Revised Offer to 7.00pm (Melbourne time) on 1 March 2024 (unless extended). You may accept the Revised Offer by:

- (a) logging into https://events.miraqle.com/BennamonIndustries-Offer/ and following the instructions; or
- (b) signing the enclosed, personalised acceptance form prepared by Bennamon and returning it to the address provided on the reply-paid envelope.

If you have already accepted the Revised Offer, no action is required.

If you are in any doubt as to the action you should take in relation to the Revised Offer, you should call the Shareholder Information Line (details of which are set out below) or contact your broker, financial adviser or legal adviser.
