The number of Consideration Shares will be determined by converting US\$6 million to AUD using the RBA exchange rate at closing and dividing that amount by the VWAP of Telix shares in the 10 trading day period up to closing. Assuming an AUD:USD rate of 0.6557 and VWAP of \$11.11, 823,481 Consideration Shares would be issued. The actual number of Consideration Shares may be more or less than this amount depending on the foreign exchange rate and VWAP at closing.
