REQUEST FOR TRADING HALT

Southern Cross Gold Limited (ASX: **SXG**) (the **Company**) requests a trading halt in relation to the Company's ordinary shares (SXG) quoted on the Australian Securities Exchange (**ASX**) in accordance with ASX Listing Rule 17.1.


The trading halt is requested pending an announcement by the Company to the market in relation to material exploration results at the Company's Sunday Creek Project ('Purpose').

In accordance with ASX Listing Rule 17.1, the Company provides the following information in relation to the request:

1. The trading halt is necessary to assist the Company in managing its continuous disclosure obligations as the Company expects to make an announcement to the market in relation to the stated Purpose above.
