BOARD CHANGES AND WITHDRAWAL OF SECTION 249D NOTICE

Withdrawal of Section 249D Notice

IPB Petroleum Limited (ASX: IPB) (**IPB** or the **Company**) refers to its ASX announcement dated 12 February 2024 regarding the receipt of a notice (**Notice**) under section 249D of the Corporations Act from Shenton James Pty Ltd, Gremar Holdings Pty Ltd, Astute Concepts Pty Ltd, Mr Gregory Hackshaw in his capacity as trustee for the Hackshaw Family A/C and Mr Gregory Robert Hackshaw (together, the **Requisitioning Shareholders**).

The Requisitioning Shareholders have withdrawn this Notice.

Accordingly, the Company advises the requirement to consider the requisitioned resolutions at a meeting of shareholders will no longer apply and hereby cancels the General Meeting that was to be held on the 8 April 2024.

Board Changes

Further to the withdrawal of the Notice, the Company advises the following changes to the board of directors, effective immediately.
