This on-market share buy-back is part of the Company's total distribution amount for the half year ended 31 December 2023 of US4.5 cents per share (US\$35.6 million), comprising an unfranked interim cash dividend of US2.25 cents per share and the undertaking of an on-market share buy-back for US\$17.8 million (equivalent in total to US2.25 cents per share).
