AFC 2019-1 Trust consists of Class A and Class B Notes amounting to \$61.694 million and \$8.232 million respectively, together totalling \$69.926 million and with a maturity in July 2025. Class A and Class B Notes carried an interest of 7.25% and 10.25% respectively. AFC 2022-1 Trust consists of Class A and Class B Notes amounting to \$10.20 million and \$1.20 million respectively, together totalling \$11.40 million and with a maturity in October 2026. Class A and Class B Notes have an interest rate of 7.00% + 3MBBSW and 10.25% + 3MBBSW respectively. The AFC 2019-1 Trust and AFC 2022-1 are secured against the funded receivables.
