### QUARTERLY ACTIVITIES REPORT

*Quarter ended 31 March 2024*

MELBOURNE, AUSTRALIA (30 April 2024): Hexima Limited (ASX:HXL) (**Hexima** or **Company**) today releases its Appendix 4C and sets out below its quarterly activities report for the quarter ended 31 March 2024.

During the quarter, Hexima continued to explore opportunities for transactions with third parties that could enhance or enable the potential value of the Company's assets, including its intellectual property and other intangible assets, to be realised. The Board continues to advance this goal of maximising shareholder value through a transaction.

#### **Financial update**

The company closed the quarter with a \$2.5m cash balance.

During the quarter \$530k net cash was generated from operating activities, including a \$695k refund from the Australian Taxation Office under the R&D Tax Incentive for the 2023 financial year, interest received of \$9k, and net operating expenditures of \$174k, which largely comprised ongoing compliance costs and professional fees.
