ASX ANNOUNCEMENT

NAB completes NAB Capital Notes 8 offer

NAB today announced that it has successfully completed the offer of NAB Capital Notes 8 (**Offer**). The Offer resulted in NAB issuing 10,000,000 NAB Capital Notes 8 at \$100 each, raising \$1 billion.

Allocation Policy

Allocations under the Offer to Syndicate Brokers and Institutional Investors were determined under the Bookbuild.

Allocations to individual Applicants were at the discretion of the relevant Syndicate Broker. Applicants should confirm their allocation of NAB Capital Notes 8 with their Syndicate Broker.

Trading on ASX

Trading of NAB Capital Notes 8 on ASX on a normal settlement basis is expected to commence on 7 June 2024 under the ASX code 'NABPK'.

Applicants are responsible for confirming the number of NAB Capital Notes 8 allocated to them under the Offer prior to selling any NAB Capital Notes 8. Applicants who sell NAB Capital Notes 8 before receiving confirmation of their allocation do so at their own risk.

Holding Statements which set out the number of NAB Capital Notes 8 issued to each successful Applicant are expected to be despatched on 13 June 2024.

Maximum Conversion Number

For the purposes of the Conversion calculations, as outlined in the NAB Capital Notes 8 Prospectus dated 21 May 2024 (**Prospectus**), the Issue Date VWAP is \$34.1880.

If a Non-Viability Trigger Event occurs and NAB converts NAB Capital Notes 8 into Ordinary Shares, the number of Ordinary Shares that a Holder will receive on Conversion is limited to the Maximum Conversion Number. Based on the Issue Date VWAP and the Face Value (being \$100 per NAB Capital Note 8), the Maximum Conversion Number is 14.6250 Ordinary Shares per NAB Capital Note 8.

First Distribution

The first Distribution¹ will be \$1.3720 per NAB Capital Note 8. The Distribution Rate for the first Distribution Period is 4.8621% per annum and is calculated as follows:

NAB Capital Notes 8 Class Ruling

The Australian Taxation Office (ATO) has advised that it expects to issue a Class Ruling for NAB Capital Notes 8 by early July. The Class Ruling will confirm certain Australian tax consequences for certain NAB Capital Notes 8 Holders.

¹ A Distribution will only be paid if the Directors resolve to pay it and a Payment Condition does not exist on the Distribution Payment Date.

² Being the Australian corporate tax rate applicable to the franking account of NAB on the relevant Distribution Payment Date. The relevant Tax Rate is currently 30%. Distributions paid on NAB Capital Notes 8 are expected to be franked at the same rate as dividends paid on Ordinary Shares. NAB's most recent ordinary dividend announced on 2 May 2024 will be franked to 100% at the company tax rate of 30%.
