Quarterly Activities Report and 4C Quarterly Cash Flow Report

Highlights:

- **GMP production run of PAT-DX1 completed during the quarter with specification testing scheduled to be completed by end of July 2024;**
- **Positive preclinical data demonstrating potential to use deoxymabs to treat vasculitis, and potentially other autoimmune diseases, presented at international meetings;**
- **Cash and short-term investment balance of \$2.2 million on 30 June 2024.**

Melbourne, Australia; 23 July 2024: Patrys Limited (ASX: PAB, “Patrys” or the “Company”), a therapeutic antibody development company, today released its Quarterly Activities Report and Appendix 4C Quarterly Cash Flow report for the quarter ended 30 June 2024.

Patrys Chief Executive Officer and Managing Director, Dr. James Campbell said: “The focus for Patrys for the April-June period was the GMP manufacturing run of PAT-DX1 which was completed during the quarter. Our Contract Manufacturing and Development Organisation advised that specification testing of the drug material from this production run is scheduled to be completed by the end of July — approximately one month later than the Company was expecting. This specification testing must be successfully completed before the drug material can be released for use in clinical trials. We were also pleased to receive positive data from preclinical studies that further highlight the potential to use our deoxymabs for various autoimmune diseases.”

Operations Update

During the quarter, the large-scale fermentation for the production of PAT-DX1 was successfully completed, and the antibody product harvested and purified using a previously established and optimized purification process. This material is required to successfully complete specification testing (product characterization and quality verification) to ensure it meets the specifications required under GMP production before it can be used in clinical trials. The delay in specification testing to the end of July 2024 will impact the timelines for planned development activities.

On 9 April 2024 Patrys announced that new data from preclinical studies using PAT-DX1 and PAT-DX3 in animal models of the autoimmune disease anti-neutrophil cytoplasmic antibody (ANCA) vasculitis was presented by Dr Kim O’Sullivan from Monash University during the plenary session of the 21st International Vasculitis Workshop in Barcelona. Related data was also presented by Dr O’Sullivan at



the annual meeting of the American Association of Immunologists in Chicago in May 2024. Highlights of the presentations were;

- PAT-DX1 inhibits the formation of neutrophil extracellular traps (NETs) from human blood neutrophils *in vitro*;
- Using an animal model of ANCA vasculitis, both PAT-DX1 and PAT-DX3 decreased NET formation and inflammation;
- Using an animal model of ANCA vasculitis, both PAT-DX1 and PAT-DX3 reduced kidney injury and resultant protein in the urine;

Previously Patrys has reported results from a range of non-clinical studies which showed that its deoxymabs suppress the formation of NETs. NETs are structures comprised of DNA strands and certain proteins produced by neutrophils (see press release entitled “*New mechanism by which PAT-DX1 may reduce cancer metastasis*”, 14 June 2022). Recent studies in both animal models and patients have indicated that NETs may play an important role in the establishment and maintenance of cancer cells, the spreading of cancer (metastasis) and in regulating inflammation. These data suggest deoxymabs may provide a therapeutic option for vasculitis that is able to reduce inflammation without suppressing the immune system. This may open up an additional indication for Patrys to develop or partner its deoxymab technology.

Patrys actively manages a business development program and collaborations with global biotech/pharma companies and academics to assess opportunities for its deoxymab technology. These opportunities span various applications, including cancer therapies and treatments for inflammatory conditions.

Corporate Update

During the quarter ended 30 June 2024, Patrys had net cash outflows of A\$764,000. At 30 June 2024, Patrys held A\$2.24 million in cash and cash equivalents. During the quarter, Patrys invested A\$527,000 in R&D activities. Payments to related parties and their associates during the quarter, which are outlined in Section 6 of the accompanying Appendix 4C to this quarterly activity report, were A\$147,000. These payments include non-executive director fees and consulting services as well as salary (including superannuation) for the CEO and Managing Director.

Based in Melbourne, Australia, Patrys (ASX:PAB) is focused on the development of its deoxymab platform of cell-penetrating antibodies as therapies for a range of different cancers. More information can be found at www.patrys.com.

About Patrys' deoxymab 3E10 platform

Patrys' deoxymab platform is based on the deoxymab 3E10 antibody that was first identified as an autoantibody in a mouse model of the human disease systemic lupus erythematosus (SLE). While most antibodies bind to cell surface markers, deoxymab 3E10 penetrates into the cell nuclei and binds directly to DNA where it inhibits DNA repair processes. Cancer cells often have high levels of mutations and underlying deficiencies in the DNA repair mechanisms. For these reasons, the additional inhibition of the DNA repair processes by deoxymab 3E10 can kill cancer cells, but appears to have little impact on normal cells. As a single agent, deoxymab 3E10 has been shown to significantly enhance the efficacy of both chemo- and radiotherapies. Further, deoxymab 3E10 can be conjugated to nanoparticles to target delivery of chemotherapeutics and imaging agents to tumours.

Patrys has developed two humanised forms of deoxymab 3E10, both which have improved activity over the original deoxymab 3E10 antibody. PAT-DX1 is a dimer (two joined subunits) of the short chain from the binding domain of deoxymab 3E10, while PAT-DX3 is a full-sized IgG antibody. In a range of pre-clinical studies, PAT-DX1 has shown significant ability to kill cancer cells in cell models, human tumour explants, xenograft and orthotopic models. PAT-DX1 has been shown to cross the blood brain barrier, reduce tumour size, and increase survival in multiple animal models of brain cancer, other cancers, and cancer metastases. PAT-DX1 is tumour-agnostic, meaning that it can target many different tumour types in the body, regardless of specific tumour antigens. Patrys believes that PAT-DX1 may have application across a wide range of cancers including gliomas, melanomas, prostate, breast, pancreatic and ovarian cancers.

Deoxymabs, such as PAT-DX1 and PAT-DX3, can be used to target nanoparticles carrying a payload of anti-cancer drugs specifically to tumours. This allows specific delivery of cancer drugs to multiple types of cancer while having minimal impact on normal, healthy cells.

Patrys' rights to deoxymab 3E10 are part of a worldwide license to develop and commercialize a portfolio of novel anti-DNA antibodies and antibody fragments, variants and conjugates discovered at Yale University as anti-cancer and diagnostic agents. Six patents covering the unconjugated form of deoxymab 3E10 (and derivatives thereof) have already been granted (Europe, Japan, China, and 3 in the USA), and five patents covering nanoparticle conjugation have been granted (Australia, Canada, China, India and the USA).
