Mr. Elie Ayoub joined the Board in June 2023 after the Company's acquisition of NexGen Australia which he jointly founded. Along with his co-founder James Harb, Elie has continued to lead the Communication & Collaboration Division which includes the NexGen business.

Mr. Elie Ayoub will continue with the Company in his executive capacity.

Commenting on the resignations, Spirit's Chairman, Mr James Joughin, said: "Greg has been on the Board of Spirit since November 2019 and has been a valuable member of various Board committees. Elie has been an Executive Director of Spirit since June 2023 and is also co-CEO of NexGen, our Communication & Collaboration business. Both Greg and Elie have been instrumental in guiding our strategy as we have restructured and refocused the Spirit business and as we continue to work towards our aim of becoming one of Australia's leading providers of modern and secure digital workplaces.

On behalf of the Board, I would like to extend our thanks to both Greg and Elie for their significant contribution to Spirit. I wish Greg the best of luck with his future endeavours, and I look forward to continuing to work with Elie in his Executive role."
