SCHEME OF ARRANGEMENT HAS BECOME LEGALLY EFFECTIVE AND SUSPENSION OF TRADING ON ASX

QANTM Intellectual Property Limited (ASX:QIP) (**QANTM**) refers to its announcement made on Friday, 2 August 2024 and confirms that it has lodged with the Australian Securities and Investments Commission (**ASIC**) an office copy of the orders made by the Supreme Court of New South Wales (**Court**) approving the acquisition by Fox BidCo Pty Ltd (**BidCo**), an entity owned and controlled by funds managed and advised by Adamantem Capital Management Pty Ltd (**Adamantem**), of all the shares in QANTM by way of scheme of arrangement (**Scheme**).

Unless otherwise indicated, capitalised terms used in this announcement have the meaning given to them in the scheme booklet in relation to the Scheme dated 25 June 2024.

Lodgement of Court Orders and Suspension of Trading

An office copy of the Court orders lodged with ASIC is attached to this Announcement as **Annexure A**.

The Scheme is now legally effective, and it is expected that quotation of QANTM Shares on the ASX will be suspended from the close of trading today (Monday, 5 August 2024).

Special Dividend

On Friday, 16 August 2024, QANTM Shareholders will be paid a fully franked special dividend of \$0.071 cash per QANTM Share held on the Special Dividend Record Date of 7:00pm (AEST) on Tuesday, 6 August 2024.

Scheme Consideration

It is expected that implementation of the Scheme will occur on Monday, 19 August 2024 and QANTM Shareholders will be provided with the Scheme Consideration (being either the Cash Consideration or Mixed Consideration (as applicable)) on that date in respect of all QANTM Shares held on the Scheme Record Date of 7:00pm (AEST) on Thursday, 8 August 2024.

QANTM Shareholders who are entitled to receive the Cash Consideration will receive an amount of \$1.746 cash (being \$1.817 less the amount of the Special Dividend of \$0.071) for each QANTM Share held.

QANTM Shareholders who have made a valid Election to receive Mixed Consideration will receive, for each QANTM Share held:

- \$0.8375 (being \$0.9085 less the amount of the Special Dividend of \$0.071); plus
- 0.9085 Class B Shares in HoldCo (to be issued to the Nominee),

subject to rounding.
