Merger update

2 September 2024, Melbourne

This announcement provides an update on Integral Diagnostics Limited's (ASX: IDX) (Integral) proposed merger with Capitol Health Limited (ASX: CAJ) (Capitol) by way of scheme of arrangement (the Merger).

On 25 July 2024, Integral applied for informal merger clearance from the Australian Competition and Consumer Commission (ACCC) to satisfy a condition precedent to the Merger.

As part of the informal merger clearance process, on 30 August 2024, the ACCC informed Integral that the ACCC will shortly publish a market inquiries letter inviting submissions from interested parties. The ACCC will also set a provisional date for the announcement of the ACCC's findings in relation to the Merger.

While the timing of the ACCC's decision is not yet fixed, Integral continues to expect that, subject to satisfaction of the conditions precedent, the Merger will be implemented in the fourth quarter of calendar year 2024.
