### **Withdrawal of resolutions at Extraordinary General Meeting**

Top Shelf International Holdings Ltd (ASX:TSI) (**Top Shelf** or the **Company**) refers to the Extraordinary General Meeting to be held as a virtual meeting on 19 September 2024 (**EGM**).

The Company advises that, in light of recent changes to Board composition and potential further Board changes which the Company is presently pursuing, all approvals relating to issues of equity to Directors of the Company will be withdrawn from the EGM.

Consequently, Shareholders will not be asked to vote at the EGM on any of Resolutions 2, 3, 4 or 5, as set out in the notice of the EGM dated 16 August 2024. All previous votes registered by shareholders in respect of Resolutions 2, 3, 4 or 5 as proxy or direct votes will be disregarded.

The withdrawal of Resolutions 2, 3, 4 and 5 will not affect the validity of the proxy form attached to the notice of the EGM or any proxy votes already submitted in respect of the sole remaining resolution to be put to shareholders for approval, being Resolution 1, approval of the sale and leaseback of the Eden Lassie property.
