

Dropsuite Vesting of Performance Rights

10 September 2024: Global cloud backup and archiving software provider Dropsuite Limited (ASX: DSE) ("Dropsuite" or the "Company") confirms the Board of Directors have resolved the issuance of 398,535 fully paid ordinary shares related to the performance rights granted under tranche 2 of the 2022 Employee Long Term Incentive Plans (LTIP) for eligible employees following satisfaction of the below hurdles:

- Employees have been employed for a period of 24 months from the date of grant; and
- Share price achieved a 30-day volume weighted average price of at least AUD\$3.20.
