Dear Shareholders

It is my pleasure to invite you to attend the 2024 annual general meeting (**AGM**) of Australian Clinical Labs Limited (**ACL** or **Company**), to be held online as a virtual meeting on Friday, 25 October 2024 at 9am AEDT. This will be the Company's fourth AGM following its admission to the ASX on 14 May 2021.

To facilitate as many Shareholders joining us as possible, the Board has determined that the AGM will be held as a virtual meeting online. This means that there will not be a physical venue for Shareholders to attend in person. Instead, the AGM will be webcast and Shareholders and their proxies, corporate representatives and attorneys will be able to attend and participate virtually through the AGM Online Platform. Full details of how to join the meeting virtually are contained in the Online Platform Guide which has been lodged with ASX and posted on ACL's website at https://investors.clinicallabs.com.au/investor-information/annual-general-meetings/. Registration will take place online and will commence at 8.30am AEDT on Friday, 25 October 2024 at https://meetings.linkgroup.com/ACL24.

The items for consideration at this year's AGM are:

- 1. The consideration of ACL's financial statements and statutory reports for the financial year ended 30 June 2024;
- 2. The adoption of ACL's Remuneration Report for the financial year ended 30 June 2024;
- 3. The re-election of Mr Michael Alscher as a non-executive Director;
- 4. The approval of the grant and issue of 221,782 Performance Rights and 114,252 Service Rights to Ms Melinda McGrath, Chief Executive Officer and Executive Director of the Company, as part of her long-term variable remuneration for the period ending 30 June 2025; and
- 5. The renewal of the approval of the LTVR Plan granted by Shareholders at ACL's 2021 AGM.

The Board recommends that Shareholders vote in favour of all items of business. Enclosed is a copy of the Notice of Meeting which includes information for Shareholders and explanatory notes. These documents can also be accessed on our website at https://investors.clinicallabs.com.au/investor-information/annual-general-meetings/.

If you are unable to attend the AGM online through the AGM Online Platform, you may (and are encouraged to) appoint a proxy to attend and vote on your behalf. Ordinary Business

Financial statements and reports

To receive and consider the financial statements, the Directors' Report and the Auditor's Report of the Company for the financial year ended 30 June 2024.

Note: No resolution is required for this item of business.

Resolution 1: Adoption of the Remuneration Report

To consider and, if thought fit, to pass the following resolution as an ordinary resolution:

"That, for the purposes of section 250R(2) of the Corporations Act and for all other purposes, the Remuneration Report of the Company for the financial year ended 30 June 2024 as disclosed in the Directors' Report be adopted."

In accordance with section 250R(3) of the Corporations Act, the vote on Resolution 1 will be advisory only and will not bind the Directors or the Company.

Voting exclusion for Resolution 1:

In accordance with the Corporations Act, a vote on Resolution 1 must not be cast, and the Company will disregard any votes cast on Resolution 1:

- (a) by or on behalf of a member of the KMP, whose remuneration details are included in the Remuneration Report and/or any Closely Related Party of such a member, regardless of the capacity in which the vote is cast; or
- (b) as proxy by any person who is a member of the KMP as at the time Resolution 1 is voted on at the meeting or a Closely Related Party of such a member,

unless the vote is cast as proxy for a person otherwise entitled to vote on Resolution 1:

- (a) in accordance with the express direction of the appointer; or
- (b) by the Chair where the proxy appointment does not specify the way the proxy is to vote on Resolution 1 and expressly authorises the Chair to exercise the proxy in respect of Resolution 1 even though the resolution is connected directly or indirectly with the remuneration of a member of the KMP.

Resolution 2: Re-election of Mr Michael Alscher as a Director

To consider and, if thought fit, to pass the following resolution as an ordinary resolution:

"That Mr Michael Alscher, retiring as a Director of the Company in accordance with rules 6.1(f)(i)(A) and 6.1(g) of the Company's Constitution and who has consented to stand for reelection (and being eligible), be re-elected as a Director of the Company in accordance with rule 6.1(i) of the Company's Constitution."

Resolution 3: Approval of grant and issue of Performance Rights to Ms Melinda McGrath

To consider and, if thought fit, to pass the following resolution as an ordinary resolution:

"That approval be given for the purposes of ASX Listing Rule 10.14, and for all other purposes, for the grant and issue of up to 221,782 Performance Rights and 114,252 Service Rights to Ms Melinda McGrath, Chief Executive Officer and Executive Director of the Company, in relation to her LTVR for FY25, in accordance with the LTVR Plan and on the terms and conditions described in the explanatory memorandum accompanying this Notice of Meeting."

Voting exclusion for Resolution 3

In accordance with the ASX Listing Rules, the Company will disregard any votes cast on Resolution 3 by or on behalf of Ms McGrath (who is a person referred to in ASX Listing Rule 10.14.1 who is eligible to participate in the LTVR Plan) or any of her Associates, regardless of the capacity in which the vote is cast.

However, this voting exclusion does not apply to a vote cast in favour of Resolution 3 by:

- (a) a person as proxy or attorney for a person who is entitled to vote on Resolution 3, in accordance with the directions given to the proxy or attorney to vote on Resolution 3 in that way; or
- (b) the Chair as proxy or attorney for a person who is entitled to vote on Resolution 3, in accordance with a direction given to the Chair to vote on Resolution 3 as the Chair decides; or
- (c) a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:
 - the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting, and is not an Associate of a person excluded from voting, on Resolution 3; and
 - the holder votes on Resolution 3 in accordance with directions given by the beneficiary to the holder to vote in that way.

The Company will also disregard any votes cast on Resolution 3 by or on behalf of any person who is a member of KMP as at the time the resolution is voted on at the meeting, or any of their Closely Related Parties, as a proxy. However, the Company will not disregard the vote of such a person on the resolution if the vote is cast by the person:

- (a) as a proxy for a person otherwise entitled to vote on Resolution 3 and the vote is in accordance with the appointor's express direction; or
- (b) the person is the Chair who has been validly appointed as a proxy for a person otherwise entitled to vote on Resolution 3 and the appointment of the Chair as proxy:
 - does not specify the way the proxy is to vote on Resolution 3; and
 - expressly authorises the Chair to exercise the proxy in respect of Resolution 3 even though Resolution 3 is connected directly or indirectly with the remuneration of a member of KMP.

Resolution 4: Renewal of Shareholder approval of the LTVR Plan

To consider and, if thought fit, to pass the following resolution as a special resolution:

"That for the purpose of ASX Listing Rule 7.2 (Exception 13) and for all other purposes, approval is given to maintain the Company's LTVR Plan on the terms and conditions described in the explanatory memorandum accompanying this Notice of Meeting and for the issue of securities pursuant to the LTVR Plan as an exception to ASX Listing Rule 7.1."

Voting exclusion for Resolution 4

The Company will disregard any votes cast on Resolution 4 by or on behalf of:

- (a) a person who is eligible to participate in the LTVR Plan or an Associate of those persons;
- (b) a member of the KMP as at the time Resolution 4 is voted on at the AGM or a Closely Related Party of such a member.

However, this voting exclusion does not apply to a vote cast in favour of Resolution 4 by:

- (d) a person as proxy or attorney for a person who is entitled to vote on Resolution 4, in accordance with the directions given to the proxy or attorney to vote on Resolution 4 in that way; or
- (e) the Chair as proxy or attorney for a person who is entitled to vote on Resolution 4, in accordance with a direction given to the Chair to vote on Resolution 4 as the Chair decides (even though Resolution 4 is connected directly or indirectly with the remuneration of a member of the KMP); or
- (f) a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:
 - the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting, and is not an Associate of a person excluded from voting, on Resolution 4; and
 - the holder votes on Resolution 4 in accordance with directions given by the beneficiary to the holder to vote in that way.

INFORMATION FOR SHAREHOLDERS

Who may vote?

In accordance with regulation 7.11.37 of the *Corporations Regulations 2001* (Cth), the Company has determined that persons whose names are set out in the register of shareholders of the Company as at 7pm AEDT on 23 October 2024 are entitled to vote at the AGM (subject to the applicable voting exclusions set out above).

How will voting be conducted?

In accordance with the *Treasury Laws Amendment (2021 Measures No. 1) Act 2021* (Cth), the Chair will put all Resolutions to a poll at the AGM. Voting results on the Resolutions that are put to the meeting (including by proxy votes) will be announced to the ASX as soon as practicable following the conclusion of the AGM.

How can I vote at the meeting?

Shareholders can vote at the meeting by:

- casting a live vote during the meeting (through the AGM Online Platform);
 or
- by appointing a proxy (see below).

Shareholders or their attorneys wishing to vote in person should attend the meeting (via the AGM Online Platform) and can vote through the AGM Online Platform.

How do I appoint a proxy?

A Shareholder who is entitled to vote at the meeting has a right to appoint up to two proxies to attend and vote for the Shareholder at the AGM. A proxy need not be a Shareholder. A proxy may be an individual or a body corporate.

Where a Shareholder appoints two proxies, the appointment should specify the proportion or number of votes which each proxy may exercise. Fractions of votes will be disregarded. If the appointment does not specify the proportion or number of the Shareholders' votes each proxy may exercise, then each proxy may exercise half those votes.

A proxy may decide whether or not to vote on any proposed resolution, except where required by law or the Company's Constitution to vote, or abstain from voting, in his or her capacity as proxy. If the Shareholder appointing the proxy:

- directs the proxy how to vote on a proposed resolution, then the proxy may vote on that resolution only in the way directed; or
- does not direct the proxy how to vote on a proposed resolution, then the
 proxy may vote on that resolution as the proxy thinks fit, subject to any
 voting exclusions that apply to the proxy; or
- directs the proxy to abstain, the proxy must not vote on the Shareholder's behalf and any vote will not be counted.

If you appoint someone as a proxy (other than the Chair) and direct them how to vote, the Chair of the AGM must cast those votes on your behalf on a poll in accordance with your directions if your proxy does not do so.

If you appoint the Chair of the AGM as your proxy (or if he is appointed by default) and no direction is provided in relation to a resolution, you will be expressly authorising the Chair to exercise your proxy as the Chair sees fit in relation to that resolution even if the resolution is connected directly or indirectly with the remuneration of the Company's KMP.

If you appoint a Director (other than the Chair) or another member of the Company's KMP or their Closely Related Parties as your proxy, you must specify how they should vote on Resolutions 1, 3 and 4 by completing the "For", "Against" or "Abstain" boxes on the proxy form. If you do not, your proxy will not be able to exercise your vote for Resolutions 1,3 and 4 (as applicable).

The Chair intends to vote all available (including undirected) proxies in favour of all Resolutions, subject to the voting exclusions described above. In exceptional circumstances, the Chair's intentions may change. If there is a change to how the Chair intends to vote undirected proxies, the Company will make an immediate announcement to ASX stating that fact and explaining the reasons for the change.

The appointment of one or more duly appointed proxies will not preclude a Shareholder from attending this meeting and voting personally. If the Shareholder votes on a Resolution, the proxy must not vote as the member's proxy on that Resolution.

To be valid, a proxy form must be correctly completed and received, either online, by post or fax or hand delivery (as per the details below), by 9am AEDT on Wednesday, 23 October 2024 (noting that hand deliveries will only be accepted during business hours (being Monday to Friday between 9:00am and 5:00pm), including any power of attorney or other authority under which it

How do I appoint/lodge a proxy?

Given changes to Australia Post's services which may see mail take longer to arrive, the Company suggests that you allow additional time if you decide to send your completed proxy form by post.

How do I appoint a corporate representative?

A Shareholder who is a body corporate and who is entitled to vote at the AGM, or a proxy who is a body corporate and who is appointed by a Shareholder who is entitled to vote at the AGM, may appoint a person to act as its representative at the AGM. The body corporate will need to ensure that it

- appoints an individual as its corporate representative to exercise its powers at meetings, in accordance with section 250D of the Corporations Act; and
- provides satisfactory evidence of the appointment of its corporate representative prior to commencement of the meeting.

Body corporate representatives should lodge this documentation with the Company's share registry by no later than 9am AEDT on 23 October 2024, unless it has been previously given to the Company.

Corporate Shareholders or proxies wishing to vote by corporate representative should:

- obtain an appointment of corporate representative form from MUFG Pension and Market Services; and
- complete and send the form in accordance with the instructions on the form.

I hold my shares jointly with another person. Are we both entitled to vote? When joint holders are named in the register of members, only one joint holder may vote. If more than one of the joint holders is present at the meeting, only the person whose name appears first in the register of members will be entitled to vote. If more than one holder votes at the meeting, only the vote of the first named of the joint holders in the register of members will be counted.

How can I ask a question at the AGM?

In accordance with the Corporations Act, a reasonable opportunity will be given to Shareholders as a whole to ask questions about or to make comments upon the management of the Company (including in respect of the Remuneration Report) and the Resolutions at the meeting via the AGM Online Platform.

Shareholders will have the opportunity to ask questions at the Meeting via the online portal at https://meetings.linkgroup.com/ACL24

Questions must be received by no later than 5pm AEDT on Friday, 18 October 2024. Questions should relate to matters that are relevant to the business of the AGM, as outlined in this Notice and the explanatory memorandum.

Questions that are relevant to:

- the contents of the Auditor's Report; or
- the conduct of the audit of the Company's financial report,

may be addressed to the Company's auditor, Pitcher Partners.

Questions will be collated and, during the AGM, the Chair will seek to address as many of the more frequently raised topics as possible and, where appropriate, will give a representative of Pitcher Partners, the Company's auditor, the opportunity to answer written questions submitted to the auditor. However, there may not be sufficient time available at the AGM to address all topics raised. Please note that individual responses will not be sent to Shareholders.

How I participate virtually?

Shareholders and proxyholders can watch, ask questions, make comments and vote in real time during the AGM (for those who are entitled to do so) through the AGM Online Platform at https://meetings.linkgroup.com/ACL24. Registration for attendance at the meeting will be online via the AGM Online Platform and will commence on 25 October 2024 at 8:30am AEDT for those accessing the AGM Online Platform. To register, Shareholders will need their shareholder number and postcode.

Proxyholders will need their proxy number which will be provided by MUFG Pension and Market Services following lodgement of the proxy appointment and no later than 24 hours prior to the meeting.

We recommend that you register at least 30 minutes before the AGM and test to see that the AGM Online Platform works on your device before the commencement of the meeting.

What happens if there are technical difficulties? Significant planning and testing has been undertaken and the online technology being used by the Company has been successfully used by other companies. However, unforeseen technical difficulties may still arise during the course of the AGM.

The Chair has discretion as to whether and how the meeting should proceed if a technical difficulty arises. In exercising his discretion, the Chair will have regard to the number of Shareholders impacted and the extent to which participation in the business of the meeting is affected. Where he considers it appropriate, the Chair may continue to hold the meeting and transact business, including conducting a poll and voting in accordance with valid proxy instructions.

As previously noted, Shareholders are encouraged to lodge a proxy by 9am AEDT on Wednesday, 23 October 2024 even if they plan to attend the meeting online via the AGM Online Platform.

What if there are changes to the meeting?

ACL will keep Shareholders informed if there are any changes to the meeting and details will be made available at https://investors.clinicallabs.com.au/, with any changes also notified by an ASX release.

EXPLANATORY MEMORANDUM

This explanatory memorandum accompanies and forms part of, and should be read together with, the Notice.

Financial statements and reports

The financial report (which includes the financial statements), the Directors' Report and the Auditor's Report for the financial year ended 30 June 2024 will be put before the AGM, as required by section 317 of the Corporations Act. The Corporations Act does not require a formal resolution of Shareholders on these reports.

These reports are contained in the Annual Report, which is available on the Company's website at https://investors.clinicallabs.com.au/. During this item of business, Shareholders will be given a reasonable opportunity to ask questions about, and to make comments on, those reports and the business and management of the Company.

Shareholders will also be given an opportunity to ask a representative of the Company's auditor, Pitcher Partners, questions relevant to the conduct of the audit, the preparation and content of the Auditor's Report, the accounting policies adopted by the Company in relation to the preparation of the financial reports and the independence of the auditor in relation to the conduct of the audit.

Resolution 1: Adoption of the Remuneration Report

Section 250R(2) of the Corporations Act requires publicly listed companies to put a resolution to shareholders to adopt the company's remuneration report for the relevant financial year.

Shareholders are asked to adopt the Remuneration Report. The Remuneration Report provides information relating to the details of the remuneration paid to KMP and Directors for the financial year ended 30 June 2024, the Company's remuneration policy and the relationship between remuneration and the Company's performance, including information about performance measures applicable to variable incentives. The Board notes that no LTVR were achieved in FY24 as the vesting conditions were not met over the FY22-FY24 measurement period, largely due to the impact of COVID-19 during this time. These LTVR have been forfeited following year end.

A copy of the Remuneration Report, which sets out remuneration arrangements for ACL can be found in the Company's Annual Report.

The Company's approach to remuneration was explained in the letter prefacing the Remuneration Report from the Chair of the Remuneration and Nomination Committee as follows:

The Board continues to ensure remuneration meets the market expectations and correctly recognises the efforts of our people, individually and collectively to grow and expand the business. Of course, individual skill is also interwoven with regard to the behaviours expected by our shareholders, the communities in which we work and our customers.

(...)

After the tumultuous period defined by the COVID-19 epidemic, we have entered a more 'business as usual' period. We again used the expertise of GRG Consulting and Calaur Advisory to help fashion STVR, LTVR and assess total remuneration of each role against the market and our competitors. We have also seen expanded demand for our skilled employees as some competitors struggle to restructure their businesses. Each manager's total remuneration has been assessed against market and competitors. These two factors have led to some changes in Variable Remuneration targets to match the change in business conditions. In FY25 our STVR will

be measured on EBITDA margin, EBITDA and personal KPIs. LTVR will move from one to three metrics. Two metrics are performance based – which align with shareholders, (rTSR and EPS) and one is service based. TSR changes from indexed to relative. Our focus on skills and growth for our management continues. Egon Zehnder has begun the initial deep skills assessments and reviews of the executives to assess development opportunities. Investing in our team is a critical element for the growth and stability of your business.

At ACL a job title rarely explains the responsibilities of any individual. Skills and experience are captured and used across all States and areas in the business, as required. ACL builds and uses structured and flexible teams to execute business enhancements. Our remuneration system aims to provide enough flexibility to recognise those contributions."

Shareholders will have a reasonable opportunity to ask questions about, or make comments on, the Remuneration Report.

Under the Corporations Act, the vote on this resolution is advisory only and does not bind the Board or the Company. However, the Company values its Shareholders' feedback in respect of this resolution and will consider any discussion on this item and the outcome of the vote when determining the future remuneration policies and practices of the Company.

In accordance with the Corporations Act, if 25% or more of the eligible votes cast are voted against the adoption of the Remuneration Report at two consecutive annual general meetings, Shareholders will be required to vote at the second of those annual general meetings on a resolution that another meeting of Shareholders be held within 90 days at which all of the Company's Directors (other than the Managing Director and the Chief Executive Officer) who were in office at the date of issue of the relevant second consecutive remuneration report must be put up for re-election.

A voting exclusion applies to this resolution, as set out in the Notice of Meeting.

Noting that each Director has a personal interest in his/her own remuneration from the Company, the Board unanimously recommends that Shareholders vote in favour of Resolution 1.

Resolution 2: Re-election of Mr Michael Alscher as a Director

Mr Michael Alscher was appointed as a non-executive Director of ACL on 19 December 2020 prior to the Company's IPO, was re-elected at the Company's first AGM on 27 October 2021 and retires at this meeting in accordance with rules 6.1(f)(i)(A) and 6.1(g) of the Company's Constitution. Being eligible, Mr Alscher stands for re-election under rule 6.1(i) of the Company's Constitution.

The proposed re-election of Mr Alscher satisfies the Company's obligations relating to the election and rotation of Directors under ASX Listing Rules 14.4 and 14.5 and ACL's Constitution.

Mr Alscher has been the Chair of ACL prior to it becoming a publicly listed company and since its acquisition by Crescent Capital Partners in 2015. Whilst the Board does not consider him to be independent due to Crescent Capital Partners being a former substantial Shareholder, the Board values Mr Alscher's expertise and deep knowledge of the Company and believes this provides considerable value to all Shareholders. The Board is particularly grateful to Mr Alscher being willing to remain as director following the recent sale by Crescent Capital Partners of its shareholding, which will provide continuity and stability for the Board as ACL continues to mature as a listed business.

Mr Alscher is the Managing Partner and founder of Crescent Capital Partners, a leading Australian private equity investment firm, specialising in high growth companies and certain industry sectors such as healthcare. Prior to founding Crescent Capital Partners in 2000, Mr Alscher was a strategy consultant at Bain International and LEK Partnership as well as holding several senior operating roles. Mr Alscher holds a Bachelor of Commerce (Finance and Mathematics) Degree from the University of New South Wales.

Mr Alscher is the current Chair of Cardno Limited, National Dental Care Limited, 24-7 Healthcare Pty Ltd and is a non-executive director of Clearview Wealth Limited, Green Leaves Early Learning Centres Pty Ltd and Aurora Expeditions Holdings Pty Ltd. Mr Alscher's former directorships include Chair of Cover-More Group Limited, LifeHealthcare Group Limited and non-executive director of Metro Performance Glass Limited, Crumpler Pty Ltd and Intega Group Limited.

The Board (with Mr Alscher abstaining) unanimously recommends that Shareholders vote in favour of Resolution 2.

Resolution 3: Approval of grant and issue of Performance Rights to Ms Melinda McGrath

ASX Listing Rule 10.14 requires the Company to obtain approval from Shareholders for the issue of securities to a Director (and certain other persons) under an employee incentive scheme (subject to certain exceptions set out in ASX Listing Rule 10.16). The Company is seeking Shareholder approval for the proposed grant and issue of up to 221,782 Performance Rights and 114,252 Service Rights to Ms Melinda McGrath, CEO and Executive Director of the Company, under the LTVR Plan for FY25 (on the basis that Ms McGrath is a Director of the Company).

Resolution 3 is not seeking approval for the total remuneration of Ms McGrath. Rather, it relates to the proposed issue of up to 221,782 Performance Rights (33% rTSR and 33% EPS) and 114,252 Service Rights (34%) to Ms McGrath, which represents the FY25 LTVR component of Ms McGrath's remuneration (which is one component of Ms McGrath's total remuneration).

If Shareholder approval is not obtained, the Board will consider alternative approaches to rewarding Ms McGrath. This may include purchasing shares on-market or paying Ms McGrath a cash equivalent

The LTVR Plan has been designed to facilitate the Company adopting modern best-practice remuneration equity structures for executives. A key component of effective remuneration for executives is equity interests, in the form of LTVR to drive shared performance objectives, link remuneration to Company performance, align interests with sustainable value creation for Shareholders and motivate and retain executive talent. Performance Rights are proposed to be granted to Ms McGrath under the FY25 LTVR grant for these reasons.

Approval of Resolution 3 under Listing Rule 10.14 will also result in any Rights the subject of this resolution granted to Ms McGrath being excepted from ASX Listing Rule 7.1. This means that any Rights the subject of this resolution granted to Ms McGrath, and any new shares issued to Ms McGrath in satisfaction of those Rights, will be excluded from the calculation of ACL's annual 15 percent new security issue limit under ASX Listing Rule 7.1.

The Company has been listed on the ASX since May 2021, including a period of volatility during the COVID-19 pandemic. The Board therefore believed that it was timely to review the executive remuneration framework, including the STVR and LTVR Plan, to ensure that it is the best-fit for the Company's future needs. This review led to a reweighting of measures in FY25 across the STVR and LTVR, together with a move away from one single measure of performance (iTSR) in the LTVR. The Board considers that the proposed Vesting Conditions for FY25 LTVR have an appropriate balance of focus on performance and retention which will support the Company to deliver on its strategy and strong shareholder outcomes. Ms McGrath's LTVR continue to have strong shareholder alignment as her LTVR is delivered through a combination of Service Rights (34%) and Performance Rights (66%), where the Vesting Conditions for the Performance Rights are EPS and rTSR based, which tie their value to the Company's share price.

In accordance with ASX Listing Rule 10.15, the features of the proposed FY25 LTVR invitations to apply for the Service Rights and Performance Rights proposed to be issued to Ms McGrath are summarised below. Capitalised terms used, but not defined in the table below, have the meaning given to them in the LTVR Plan (a copy of which was released to the ASX Market Announcements Platform on 14 May 2021).

The number of Rights proposed to be granted to Ms McGrath for FY25 was determined by dividing the dollar value of Ms McGrath's LTVR opportunity (being 100% of Ms McGrath's total fixed remuneration as at 1 July 2024) by the Volume Weighted Average Price (**VWAP**) of Shares over the trading period from 30 August 2024 to 12 September 2024 (inclusive) less the FY24 declared dividend and assumed dividends for the next 3 financial years, being \$2.68 (the **Issue Price**).

When added to the other remuneration elements, the FY25 grant of LTVR for Ms McGrath will produce a total remuneration package that the Board believes is market competitive and appropriate given the Company's circumstances for FY24, based on market benchmarking and the current ACL executive remuneration policy.

100% of Rights to be granted will only vest when Vesting Conditions are achieved, and it is expected that a lesser percentage will actually vest unless exceptional performance outcomes occur.

The actual value (if any) that Ms McGrath will receive from the proposed FY25 LTVR grant cannot be determined until the end of the Measurement Period, and will depend on the extent to which the Vesting Conditions are achieved, the number of Performance Rights that vest in accordance with the Vesting Conditions and the ACL Share price at the time of vesting.

The Board determined the value and form of Ms McGrath's FY25 LTVR award under the Plan in Performance Rights with regard to her overall remuneration package, the nature of her position, the purpose of the LTVR component in ACL's remuneration strategy and independent benchmarking regarding current market practice.

Performance Measurement Period

The Performance Measurement Period is the period over which Vesting Conditions are assessed.

For Tranches 1 and 2 of the Performance Rights, the Measurement Period will be three years from 1 July 2024 to 30 June 2027.

The expected Vesting Date, subject to meeting Vesting Conditions, for all Tranches is 15 September 2027.

Vesting Conditions

Vesting Conditions are conditions that are used to determine the extent, if any, of vesting of Performance Rights.

For Tranche 1, the Vesting Condition is a market-standard rTSR vesting schedule that sees 50% vest if the Company achieves 50th percentile rTSR (against the ASX300 peer group, being ASX300 ex-Financials and Resources Index), with straight line vesting to 100% vesting if the Company achieves 75th percentile rTSR. If the 50th percentile rTSR performance is not achieved, Tranche 1 of the LTVR lapses and is forfeited. The rTSR performance of the Company and the members of the ASX300 peer group will be measured on a 4-week VWAP, two weeks either side of the testing date of 30 June 2027.

For Tranche 2, the Vesting Condition is a straight-line vesting schedule that commences at 4% EPS CAGR (threshold) to 100% at 10% EPS CAGR (stretch)

and will be measured with FY24 EPS as the base year to FY27 EPS as at 30 June 2027.

For Tranche 3, the Vesting Condition is binary with the continuous service condition fulfilled or not fulfilled as at 15 September 2027.

If necessary to avoid an anomalous result, the Board may make adjustments in measuring performance to ensure the intent of the incentive plan is maintained. The Board also retains absolute discretion to increase or decrease including to nil, the extent of vesting in relation to each Tranche of Rights if it forms the view that it is appropriate to do so given the circumstances that prevailed during the Measurement Period. In exercising this discretion, the Board shall take into account, amongst other factors it considers relevant, Company performance from the perspective of Shareholders over the relevant Measurement Period. Before exercising its discretion the Board may seek advice from an independent advisor as to whether the discretion should be exercised and if so then the alternative extent of vesting that should be considered by the Board.

Acquisition price and Exercise Price

No amount is payable by Ms McGrath for the Rights as their value forms a significant portion of the variable remuneration in her total remuneration package for FY25. The Exercise Price for the Rights is nil.

Exercise of vested Rights

Vested Rights may be exercised by the Participant submitting an Exercise Notice at any time between the Vesting Date (or the latter elapsing of Exercise Restrictions, if applicable) and the end of their Term. Otherwise, these Rights will lapse.

On exercise of vested Rights, the Board will determine in its absolute discretion whether to settle the Exercised Rights Value in whole Shares (including Restricted Shares), a cash payment or a combination of whole Shares and a cash payment.

Generally, it is expected that the Exercised Rights Value will be settled in Shares. Such Shares will often be Restricted Shares as they will be subject to Disposal Restrictions if the exercise occurs during a period in which trading in Shares is prohibited under the ACL securities trading policy.

Disposal restrictions

Rights may not be sold, transferred, mortgaged, charged or otherwise dealt with or encumbered, except by force of law.

Shares acquired from the exercise of vested Rights will be subject to disposal restrictions due to:

- the Company's securities trading policy; and
- the insider trading provisions of the Corporations Act (Division 3 of Part 7.10).

Shares resulting from the exercising of Rights that may not be traded due to the foregoing will be Restricted Shares while they are so restricted. ACL will ensure that such restrictions are enforced due to the presence of CHESS holding locks or alternatively via holding of the Restricted Shares in an EST.

Disposal and Exercise Restriction release at taxing point

In the event that a taxing point arises in relation to Rights or Restricted Shares and the Exercise Restrictions or Specified Disposal Restrictions have not elapsed, then they will cease to apply to 50% of the taxable Rights and Shares. This ensures that unreasonable tax outcomes are avoided.

Termination of Employment

In the case of a termination of employment:

- (a) unvested Rights will be forfeited, unless and to the extent otherwise determined by the Board in its discretion;
- (b) vested Rights subject to Exercise Restrictions will cease to be subject to Exercise Restrictions: and
- (c) vested Rights will lapse if not exercised within 21 days of the date of cessation of employment with the Group.

Change of Control

In the event of a Change of Control, unvested Rights will vest in the proportion that the elapsed portion of the Measurement Period bears to the full Measurement Period. The Board, in its discretion, may determine that none, some or all of the remaining unvested Rights also vest. Any Rights that remain unvested following exercise of the Board's discretion will lapse.

Major return of capital or demerger

In the event that the Board forms the view that a major part of the Company's assets or operations will imminently cease to be owned by the Group due to an intention to sell or separately list those assets or operations, or in the event of a major return of capital to Shareholders;

- (a) unvested Performance Rights and unvested Service Rights will either vest to the extent determined by the Board, with the remainder lapsing, or the Board will adjust the number and vesting conditions of Performance Rights and Service Rights held so that Participants are neither advantaged nor disadvantaged by the return of capital or demerger, and
- (b) Restricted Rights will cease to be subject to Exercise Restrictions prior to the return of capital or demerger, on the date determined by the Board.

Board discretion to prevent inappropriate benefits, fraud and misconduct

The Board has discretion to adjust the number of Rights that ultimately vest if it forms the view that the unadjusted outcome is not appropriate to the circumstances that prevailed over the Measurement Period and/or to the contribution of a Participant to outcomes over the Measurement Period.

The Board has sole discretion to determine that some or all unvested Rights held by a Participant lapse on a specified date, if allowing the Rights to be retained would, in the opinion of the Board, result in an inappropriate benefit to the Participant. Such circumstances include joining a competitor or actions that harm the Company's stakeholders.

In the case of fraud or misconduct, the Participant will forfeit all unvested Rights.

Bonus issues, rights issues, voting and dividend entitlements

In cases of bonus share issues by the Company, the number of Rights held by a Participant shall be increased by the same number as the number of bonus shares that would have been received by the Participant had the Rights been Shares, except in the case that the bonus share issue is in lieu of a dividend payment, in which case no adjustment will apply.

Rights do not carry voting or dividend entitlements. Shares (including Restricted Shares) issued when Rights are exercised carry all entitlements of Shares, including voting and dividend entitlements.

Quotation	Rights will not be quoted on the ASX. The Company will apply for official quotation of any Shares issued under the Plan, in accordance with the ASX Listing Rules.
Issue or acquisition of Shares	Shares allocated to a Participant when Rights are exercised under the Plan may be issued by the Company or acquired on or off market by a trustee whose purpose is to facilitate the operation of the Plan.
Cost and administration	The Company will pay all costs of issuing and acquiring Shares for the purposes of satisfying exercised Rights, as well as any brokerage on acquisitions of Shares for this purpose and all costs of administering the Plan.
Hedging	The Company prohibits the hedging of Rights or Shares subject to disposal restrictions by Ms Melinda McGrath.

Other details

Further information in accordance with ASX Listing Rule 10.15:

- Ms Melinda McGrath is the only person both subject to ASX Listing Rule 10.14 and entitled to participate in the Plan, as at the date of the preparation of this Notice of Meeting;
- 247,252 Performance Rights have been previously issued to Ms McGrath under the Plan in respect of the financial year ending 30 June 2022, 485,344 Performance Rights have been previously issued to Ms McGrath under the Plan in respect of the financial year ending 30 June 2023 and 880,836 Performance Rights have been previously issued to Ms McGrath under the Plan in respect of the financial year ended 3 June 2024. These Performance Rights were issued for nil consideration under the Plan. On 29 August 2024, 247,252 Performance Rights were forfeited because Vesting Conditions were not met;
- Ms McGrath's current total remuneration package (for FY25) is set out in the Annual Report and is as set out below:
 - total fixed remuneration for FY25 of \$900,000;
 - a short-term variable incentive which the Board currently values as follows:
 - at Target \$450,000; and
 - at Stretch \$675,000;
 - o LTVR, which the Board currently values as follows:
 - at Target \$450,000 (being 168,017 Rights multiplied by the Issue Price); and
 - at Stretch \$900,000 (being 336,034 Rights multiplied by the Issue Price).

Ms McGrath's total remuneration package at LTVR Threshold is therefore currently valued at \$1,800,000 at Target and \$2,4750,000 at Stretch;

- no loans have been, or will be, provided by the Company in relation to the grant or exercise of the Performance Rights proposed to be provided to Ms McGrath;
- details of any securities issued under the Plan will be published in the Company's annual report relating to the period in which they were issued, along with a statement that approval for the issue was obtained under ASX Listing Rule 10.14;
- any additional persons covered by ASX Listing Rule 10.14 who become
 entitled to participate in an issue of securities under the Plan after this
 Resolution 4 is approved and who are not named in this Notice will not
 participate until approval is obtained under ASX Listing Rule 10.14; and
- a voting exclusion applies to Resolution 3, as set out in the Notice of Meeting.

The Directors (with Ms Melinda McGrath abstaining) unanimously recommend that Shareholders vote in favour of Resolution 3. The Chair of the AGM intends to vote all available proxies in favour or Resolution 3.

Resolution 4: Renewal of the approval of LTVR Plan

The purpose of Resolution 4 is to renew Shareholder approval to maintain the Company's LTVR Plan to provide ongoing incentives to assist in the motivation, retention and reward of eligible employees. If this Resolution is passed, the LTVR Plan will enable the Company to issue Securities from time to time to eligible employees as part of a performance-based incentive program (which will be subject to vesting conditions set by the Board), as an exception to ASX Listing Rule 7.1.

The Board has the discretion to determine which employees are eligible to participate in the LTVR Plan and the number of Securities they will be offered.

The Company wishes to exempt issues of securities under the LTVR Plan from contributing towards the rolling annual limit of 15% of equity securities prescribed by ASX Listing Rule 7.1 (i.e. the 15% placement capacity). This limit otherwise applies to all new issues of equity securities made without Shareholder approval.

The purpose of the LTVR Plan is to align the interests of employees with the interests of Shareholders by providing an opportunity for employees to receive an equity interest in the Company.

Resolution 4 seeks Shareholders' approval for the adoption of the LTVR Plan for the purposes of ASX Listing Rule 7.2 (Exception 13(b)) as an exception to ASX Listing Rule 7.1 (whereby Shareholders may approve in advance the issue of securities made under the LTVR Plan as an exception to the limit under Listing Rule 7.1).

The LTVR Plan will operate in accordance with ASIC class order CO 14/1000 (Class Order).

In accordance with ASX Listing Rule 7.2 (Exception 13), the number of Rights issued under the LTVR Plan since the LTVR Plan was last approved by Shareholders at the 2021 AGM on 27 October 2021 is 6,073,669 Securities. As at the date of this Notice, the Company proposes that the maximum number of Securities to be granted under the LTVR Plan within the three year period following approval of this resolution will not exceed 10,091,701 Rights (being 5% of the Shares on issue as at 13 September 2024).

ASX Listing Rule 7.1

ASX Listing Rule 7.1 provides that a company must not, subject to specified exceptions, issue or agree to issue more equity securities during any 12 month period than that amount which represents 15% of the number of fully paid ordinary Shares on issue at the commencement of that 12 month period without the approval of Shareholders.

ASX Listing Rule 7.2 (Exception 13(b)) sets out an exception to ASX Listing Rule 7.1 which provides that an issue of Securities under an employee incentive scheme are exempt from Listing Rule 7.1 for a period of three years from the date on which Shareholders approve the issue of Securities under the scheme as an exception to ASX Listing Rule 7.1.

If Resolution 4 is passed, the Company will be able to issue Securities under the LTVR Plan to eligible participants over a period of three years from the date of the resolution without impacting on the Company's ability to issue up to 15% of its total ordinary Shares without Shareholder approval in any 12 month period. If Resolution 4 is not passed, any Securities issued under the LTVR Plan to eligible participants may impact the Company's ability to issue ordinary Shares for other purposes.

A summary of the key terms and conditions of the LTVR Plan is set out below.

Forfeiture/lapse of Rights

In various circumstances unvested Rights should be forfeited, subject to Board discretion, including:

- fraud, defalcation and gross misconduct;
- if a Participant engages in any activities or communications that, in the opinion of the Board, may cause harm to the operations or reputation of the Company or the Board;
- if the Board determines that a Participant or Participants took actions that caused harm or are expected to cause harm to the Company's stakeholders:
- if the Board forms the view that a Participant or Participants have taken excessive risks or have contributed to or may benefit from unacceptable cultures within the Company;
- if the Board forms the view that Participants have exposed employees, the broader community or the environment to excessive risks, including risks to health and safety;
- if a Participant joins a competitor (unless otherwise determined by the Board); and
- if there has been a material misstatement in the Company's financial reports, which once resolved, indicates that a larger number of Rights previously vested than should have, in light of the corrected information.

Dividend and voting entitlements

Rights do not carry dividend or voting entitlements. Shares and restricted shares received following exercise of a Right will be Shares that carry dividend and voting entitlements.

Restrictions

Rights may not be sold, transferred, mortgaged, pledged, charged, granted as security or otherwise disposed of, unless required by law.

Quotation

Participants must not enter into any arrangement for the purpose of hedging, or otherwise affecting their economic exposure to any unvested Rights. Rights, except Shares, will not be quoted on the ASX. The Company will apply for official quotation of any Shares issued under the LTVR Plan, in accordance with the Listing Rules.

Cessation of employment

In the event of a cessation of employment during a measurement period any unvested Rights will be forfeited in full.

Vested Rights held following termination of employment must be exercised within 21 days of the latest date when no unvested Rights are held by the Participant.

Malus and clawback

In various circumstances, unvested Rights should be forfeited, subject to Board discretion, including:

- fraud, defalcation and gross misconduct;
- if a Participant engages in any activities or communications that, in the opinion of the Board, may cause harm to the operations or reputation of the Company or the Board;
- if the Board determines that a Participant or Participants took actions that caused harm or are expected to cause harm to the Company's stakeholders;

- if the Board forms the view that a Participant or Participants have taken excessive risks or have contributed to or may benefit from unacceptable cultures within the Company,
- if the Board forms the view that Participants have exposed employees, the broader community or the environment to excessive risks, including risks to health and safety;
- if a Participant joins a competitor (unless otherwise determined by the Board); and
- if there has been a material misstatement in the Company's financial reports, which once resolved, indicates that a larger number of Rights previously vested than should have, in light of the corrected information.

Change of control

In the event of a change of control, unvested Rights will vest in the proportion that the elapsed portion of the measurement period bears to the full measurement period. The Board, in its discretion, may determine that none, some or all of the remaining unvested Rights also vest. Any Rights that remain unvested following exercise of the Board's discretion will lapse.

Plan Limit
