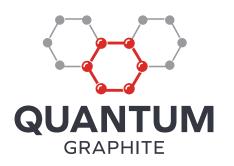

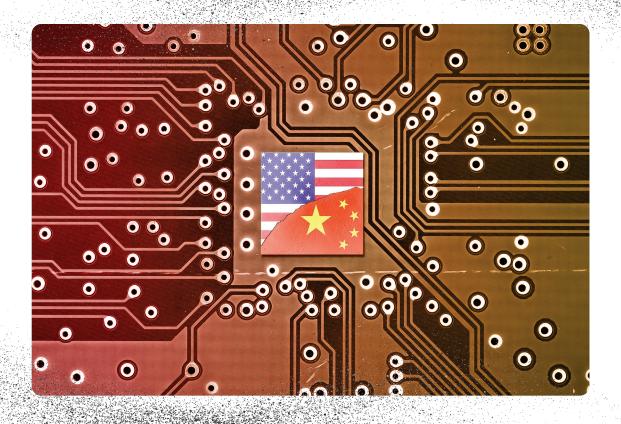

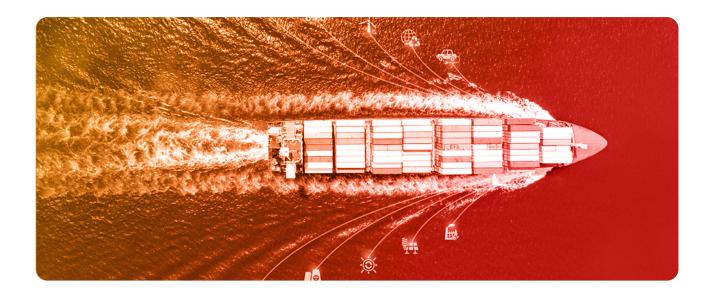

DIRECTORS' REPORT

The Directors of Quantum Graphite Ltd present their report on the Company and its subsidiaries, for the year ended 30 June 2024. Director details including relevant personal information is included in the Remuneration Report.

PRINCIPAL ACTIVITIES

Our principal activities are the exploration, mining and processing of natural flake graphite and the manufacture of flake graphite products. The Company has historically supplied high purity large flake graphite powders from its Uley 1 mine operation and processing facility to the refractories markets in Europe and North Asia.

Our future activities are:

- The development of the Uley 2 and Uley 3 mining and processing facilities, the next stage of development of the Company's flagship Uley flake graphite deposit; and
- The manufacture of natural flake-based products including thermal storage media by Sunlands Power Pty Ltd (Sunlands Power), the Company's joint venture with The Sunlands Energy Company Pty Ltd (SEC).

THE GRAPHITE WORLD ORDER CHANGES YET AGAIN...

The global supply of flake graphite, and especially the supply servicing the lithium-ion anode battery market, remained substantially unchanged by the end of the period. For the whole of the 2024 fiscal year, the market for natural flake graphite continued to be dominated by Chinese processors sourcing material from China and East Africa. The Company estimates that a single Chinese company represents more than three-quarters of the overall flake being processed into anode material.

But this picture conceals the turmoil during the year experienced by market participants in the U.S, Europe, Japan and Korea (Non-China Market). All sought to accelerate plans to diversify graphite (and the manufacture of active anode material) supply chains away from established Chinese suppliers. In the last quarter of 2023, China's Ministry of Commerce announced its graphite export restrictions which were implemented in December 2023. The efforts of the Non-China Market participants intensified and by the end of the Australian summer, a number of these participants were carefully planning the implementation of supply-chain diversification strategies.

However, tangible supply from these strategies would not bear fruit in the short term. Consequently, the Non-China Market automakers and their OEMs (original equipment manufacturers) faced the prospect that continued sourcing from China for anode would jeopardise eligibility for the U.S Inflation Reduction Act (IRA) tax rebate. This rebate is generally available for all purchasers of passenger electric vehicles manufactured and sold in the U.S and represents a key incentive supporting the transition of the U.S passenger fleet to electric vehicles.



The rules governing IRA tax rebate eligibility explicitly require Li-ion battery components (and critical minerals essential in the manufacture of these components) be manufactured in the U.S or a U.S FTA country. To assist Non-China Market automakers and their OEMs comply with this requirement they were permitted a transition period, as proscribed by regulation under the IRA, to establish appropriate supply chain arrangements.

This sourcing requirement can generally be met for most battery components. However, it is impossible to fulfil this requirement in the case of the production of anode (and especially graphite required for anode manufacture) as this production is completely controlled within China or globally by Chinese processors. Moreover, Non-China Market automakers and their OEMs considered that alternative supply chains could not be established within the transition period.

In early May, the U.S. Federal Treasury together with the Department of Energy addressed this uncertainty specifically in respect of graphite. Revised regulations were issued permitting up to 20 percent of the critical minerals in the manufacture of battery components be sourced from non U.S, non FTA country sources i.e., China or China-owned processors and manufacturers in the Li-ion battery supply chain. This specific change now opens the way for IRA tax concession eligibility for all vehicles manufactured for sale in the U.S. by U.S., European, Japanese, and Korean automakers.

At the end of the financial year, these automakers and their OEMs appeared to remain committed to diversification of the Li-ion battery processing and manufacturing supply chain. However, this position changed by mid-August 2024 when the Company's discussions with market participants reflected a revision of priorities with many of the Non-China Market automakers and their OEMs renewing or restructuring pre-existing arrangements within the Chinese anode supply chain.

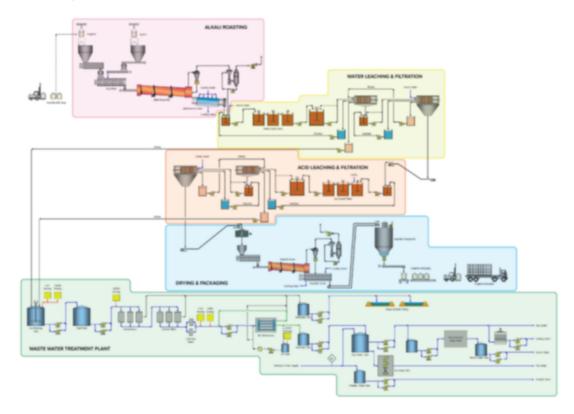
By mid-August 2024, China Bao An Group Co. Ltd, the parent company of BTR New Materials Group Co. Ltd (BTR) announced that BTR had entered into an agreement with Ford Motor Co. in which the automaker would pay BTR US\$120 million in exchange for anode materials supply commitments from BTR's new facility in Morocco. BTR had earlier confirmed an expansion of its recently completed anode facility in Indonesia to double capacity from the existing capacity of approximately 80,000 tonnes per annum to 160,000 tonnes per annum within two years.

...But the plan remains unchanged, from the Uley 2 mine to high purity graphite production... an integrated independent graphite supply chain

For the past 5 years, the Board implemented its plan to establish a level of commercial diversification and preparedness that enables the Company to meet and aggressively exploit the increased demand for its products.

The collaboration with Sunlands Energy Co. has established a demand source, long duration energy storage (LDES), that has a market size many times that of the Li-ion battery market. The collaboration with Sunlands Energy Co. has also delivered a path for Uley 2 production to be refined into high purity graphite at a highly scalable level essential for the future development of the Non-China Market Li-ion battery supply chain.

As foreshadowed in our interim report, the Board's priority is now establishing the appropriate funding structure to enter the graphite market as a major producer and refiner of high purity graphite and remain firmly in control of the sales and marketing of this most-valuable product.



OPERATING AND FINANCIAL REVIEW

The net loss for the year was \$4,368,833 (2023: \$5,159,466). Our financial performance is better than plan however this is mainly due to:

- Deferring certain elements of the Company's exploration plans (i.e., the Uley Near Term and District Exploration Plans)
 due to the longer than expected timeframe for the issue of the approval (MPEPR2023/048) by the South Australian
 Department of Energy and Mining; and
- Deferring certain research and development expenditures pending the issue of the Advance Overseas Finding Certificate by AusIndustry to the Company and SEC.

The Company continues to benefit from the ongoing research and development activities based on the core technologies developed by SEC. The issue of the Advanced Overseas Finding provides considerable support in the form of the Commonwealth Government's research and development tax concession for those activities we are compelled to undertake overseas.

The Company's update to the 2019 Definitive Feasibility Study (2023 DFS Update), exploration commitments and extensive research and development programs are fully funded and continue to underpin an optionality in the natural flake industry unmatched by competitors. The last three years' work has produced results which, though attracting little attention, have positioned the Company to exploit the massive uncertainties in the graphite supply chain.

These technologies and the diversity they deliver to our commercialisation plans are designed to ensure preparedness across a number of market segments including the lithium-ion battery markets (i.e., electric vehicle and grid connected storage). The Company remains committed to a market offering that is focused on high value, high purity flake (i.e., >99% graphitic carbon) and maintains:

- · Process and purification plant design that has extensive product optionality; and
- Production capabilities that can deliver a single, bulk and scalable high purity specification.

2023 DFS Update

In December 2023, the Company announced the details of the 2023 DFS Update, a substantial upgrade to the original 2019 Definitive Feasibility Study. The 2023 DFS also included results of the 2023 Value Engineering Assessment (VEA).

The 2023 DFS Update and the VEA (collectively, the Studies) were completed by Lycopodium Minerals and prepared on the basis of maximising mill throughput to 1,200,000 tpa (cf. 550,000 tpa, 2019 DFS) and increasing the basket price to US\$1,225 per tonne of gC (cf. US\$919 per tonne, 2019 DFS).

The key results of the Studies were:

- Revised capital costs of A\$152.7 million (cf. A\$79.8 million, 2019 DFS);
- Revised production costs (Av LOM) of US\$401 dmt (cf. US\$368 dmt, 2019 DFS);
- A material decrease in processing costs to 50.8% of total costs (cf. 71% 2019 DFS); and
- A substantial decrease in fixed costs as a share of processing costs to 35% (cf. 62%, 2019 DFS).

The Studies demonstrate a substantial improvement to the economics of Uley 2. Importantly, the doubling of production and the consequential increase in efficiencies, now provide the capability to withstand very significant market volatility and lock in materially lower quartile operating costs compared with comparable projects.

Uley 2 and Uley 3 Resource Expansion Program

During the period, the Company announced details of a comprehensive exploration plan that provides for near term resource expansion of Uley 2 and Uley 3 (Uley Near Term Exploration Plan) and the commencement of work to build a resource base across the broader exploration lease, EL6224 (District Exploration Plan).

The issue of M-PEPR2023/048 by the South Australian Department of Energy and Mining during the period authorises the first phase of a drilling program under the Uley Near Term Exploration Plan. This drilling program together with recently completed exploration activities is designed to increase the Uley 2 and Uley 3 JORC 2012 mineral resources.

A helicopter-borne geophysical survey over all the Company's mineral tenements was completed during the period following a ground based geophysical survey over the Uley 2 Project mineral lease areas. These surveys are considered critical exploration activities for both the Uley Near Term Exploration Plan and the District Exploration Plan. Completion of the surveys marked the final step in the preparation of the Uley Near Term Exploration Plan and provides the essential data necessary for the commencement of work on the District Exploration Plan.

Mobilisation of drill crews was expected before the end of the period but was deferred following additional analysis to refine certain drill hole locations.

At the date of this report, the Company's technical team has not concluded its interpretation of the geophysical surveys. This work is now expected to be completed by the end of October 2024 and the results will settle all drill hole locations and the scheduling of drill crew mobilisation. The interpretation work to date has resulted in a refinement of the Company's geological model of the Uley 2 and Uley 3 region and the existing mineralisation patterns within EL 6224. The revised mineralised patterns within EL 6224 are a direct result of mapping the airborne geophysical responses that correspond to the same responses over known regions of major graphitic carbon mineralisation including within the Uley 2 project area.

Equity Capital Issues

On 28 November 2023, the Company issued 514,169 fully paid ordinary shares in lieu of Director fees and Company Secretary fees accrued to 31 December 2023.

Further equity issues were completed on 4 July 2024 and 10 July 2024 and are detailed below in Events Arising Since The End Of The Reporting Period.

Working Capital Financing

The Company's working capital facility with Chimaera Capital Limited was varied by way of amendments to the Credit Facility Deed on 28 December 2023 and 21 June 2024. The variations increased the amounts available under the facility. The amount available under the facility is \$4,400,000 and the repayment date is specified as the earlier of 1 November 2025 or the next capital raising.

Mining Titles

All mining titles are current and remain in good standing. On 22 February 2023, the Company was notified of the renewal of EL6224 to 12 October 2027. On 24 August 2023, the Company's Retention Leases (RL) 66 and 67 were renewed to 1 October 2026.

Significant Changes In The State Of Affairs

Apart from equity capital issues as disclosed above, there have been no significant changes in the state of affairs of the Group that occurred during the reporting period and that has not otherwise been disclosed in this report or the financial statements.

Dividends

There were no dividends paid or declared during the reporting period or to the date of this report.

Events Arising Since The End Of The Reporting Period

On 18 July 2024, the Company and Sunlands Energy Co. received a single Letter of Interest (LOI) and non-binding Indicative Term Sheet from US EXIM Bank (EXIM) for a financing commitment of up to US\$300 million under EXIM's Make More in America initiative for a total flake graphite supply chain solution encompassing the following activities:

- · The Uley 2 Project;
- · Processing and refining to produce high purity graphite; and
- · Warehousing, inventory management and logistics facilities.

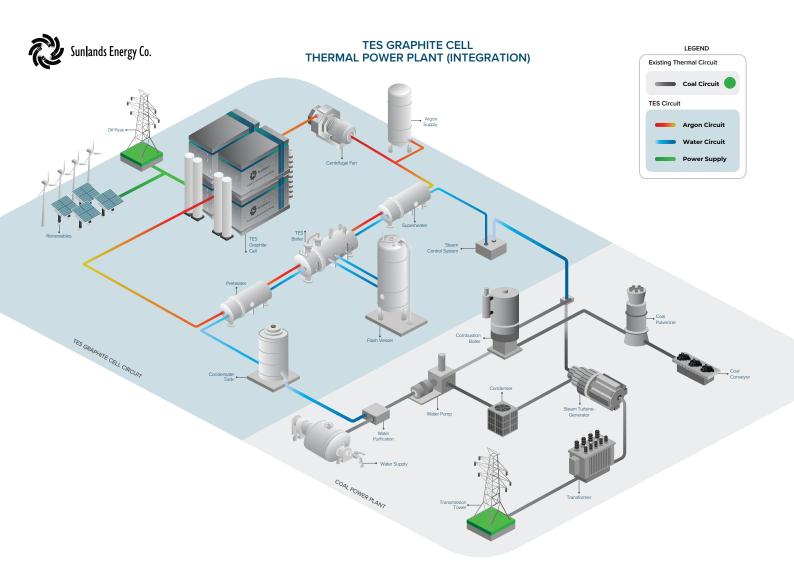
The LOI and Indicative Term Sheet also stated that the Company and Sunlands Energy Co. may qualify for funding under the bank's China and Transformational Exports Program (CTEP).

The parties have responded to EXIM that they will proceed with the formal provision of information and begin planning for the bank's due diligence processes.

Since the end of the reporting period, the Company completed the following issue of securities:

- On 4 July 2024, the Company issued 3,400,000 fully paid ordinary shares to consultants at A\$0.503 in lieu of consultant fees accrued to 30 June 2024.
- On 10 July 2024, the Company completed a placement to sophisticated investors and issued 3,404,450 fully paid ordinary shares at A\$0.44059 per share to raise approximately \$1,500,000. The shares were issued at a 10% discount to the five-day volume weighted average price (VWAP) ending on 4 July 2024.

No other matters or circumstances have arisen since the end of the financial period which significantly affected or may significantly affect the operations of the Group, the results of those operations or the state of affairs of the Group in subsequent financial years.

The Directors of Quantum Graphite Ltd present the Remuneration Report in accordance with the Corporations Act 2001 and the Corporations Regulations 2001.

A. Principles Used to Determine the Nature and Amount of Remuneration

The Company's remuneration policy has been designed to align objectives of key management personnel with objectives of shareholders and the business, by providing a fixed remuneration component and offering specific long-term incentives through the issue of options and / or performance rights. The Board believes the remuneration policy to be appropriate and effective in its ability to attract and retain the best key management personnel and Directors to run and manage the Company. The key management personnel of the Company are the Board of Directors and Executive Officers.

The Board's policy for determining the nature and amount of remuneration for its members and key management personnel of the Company is as follows:

- The remuneration policy, setting the terms and conditions for the executive Directors and key management personnel, is developed by the Board. All key management personnel are remunerated on a consultancy or salary basis based on services provided by each person. The Board annually reviews the packages of key management personnel by reference to the Group's performance, executive performance and comparable information from industry sectors and other listed companies in similar industries.
- The Board may exercise discretion in relation to approving incentives, bonuses, options and performance rights. The policy is designed to attract the highest calibre of key management personnel and reward them for performance that results in long-term growth in shareholder wealth.
- Key management personnel were also entitled to participate in the Company's Performance Rights and Option Plan as approved by shareholders at the 2013 AGM.
- The Board policy is to remunerate non-executive Directors at market rates for comparable companies for time, commitment and responsibilities. The Board determines payments to the non-executive Directors and reviews their remuneration annually, based on market practice, duties and accountability. Independent external advice is sought when required. The maximum aggregate amount of fees that can be paid to non-executive Directors is subject to approval by shareholders at the Annual General Meeting. Fees for non-executive Directors are not linked to the performance of the Company, except in relation to KPI options. Additionally, to align Directors' interests with shareholder interests, the Directors are encouraged to hold shares in the Company and are able to participate in the Performance Rights and Option Plan.

During the reporting year, performance reviews of senior executives were not conducted.

Performance Based Remuneration

The remuneration policy has been tailored to increase goal congruence between shareholders, directors and other key management personnel. This has been facilitated through the issue of options and/or performance rights to key management personnel to encourage the alignment of personal and shareholder interests. The Company believes this policy will be effective in increasing shareholder wealth.

Notes to the Consolidated Financial Statements

For the year ended 30 June 2024

These are the financial statements of Quantum Graphite Ltd ('the Company') and its subsidiaries (together 'the Group'), for the year ended 30 June 2024.

1. General Information

a) Nature of operations

Quantum Graphite Ltd's principal activity is the manufacture of high-grade flake graphite products and the mining of and exploration for graphite deposits in South Australia.

b) Basis of preparation

The consolidated general purpose financial statements of the Group have been prepared in accordance with the requirements of the Corporations Act 2001, Australian Accounting Standards and other authoritative pronouncements of the Australian Accounting Standards Board (AASB). Compliance with Australian Accounting Standards results in full compliance with the International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board (IASB).

Quantum Graphite Ltd is a listed company, registered and domiciled in Australia. Quantum Graphite Limited is a for-profit entity for the purpose of preparing the financial statements.

The consolidated financial statements for the year ended 30 June 2024 were approved and authorised by the Board of Directors on 24 September 2024.

The financial statements have been prepared under the historical cost convention.

c) Going concern basis of accounting

The financial statements have been prepared on the going concern basis, which contemplates continuity of normal business activities and the realisation of assets and discharge of liabilities in the normal course of business.

As disclosed in the financial statements, the Group incurred a loss of \$4,368,833 and net cash outflows from operating activities of \$1,391,216 for the year ended 30 June 2024. Also, as at 30 June 2024, the Group's current liabilities exceeded its current assets by \$1,089,876 (Excess Current Liabilities).

The Directors, after reviewing the cash flow forecast for a period of twelve months after the signing of this financial report, concluded that there are reasonable grounds to believe that the Group will continue as a going concern and that it is appropriate to adopt the going concern basis in the preparation of the financial statements. The Directors' assessment considered the following factors:

- As at 30 June 2024, 90% (i.e., \$980,888) of Excess Current Liabilities is to be satisfied by way of the issue of shares. This
 amount includes payables in respect of consultants' fees and Directors' and Officers' fees;
- On 10 July 2024, the Company completed a placement to sophisticated investors issuing 3,404,450 fully paid ordinary shares at A\$0.44059 per share raising \$1,499,967, net of transaction costs (see Note 25);
- The Group's expenditure commitments, under the terms of the exploration licenses, have been met and currently there are
 no other significant operational commitments. The Group has the discretion to vary the timing and scope of its exploration
 and evaluation activities; and
- If required, the Directors will seek to raise additional capital from existing and new shareholders, and are confident that this is feasible based on the Group's history of successful capital raises.

Accordingly, the Directors believe that the Group will be able to continue as a going concern and that it is appropriate to adopt the going concern basis in the preparation of the financial report.

2. Material Accounting Policies

The principal accounting policies that are material to the Group are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

a) Principles of Consolidation

The consolidated financial statements incorporate the assets and liabilities of all subsidiaries of Quantum Graphite Ltd ("the Company" or "the parent entity") as at 30 June 2024 and the results of all subsidiaries for the year then ended. Quantum Graphite Ltd and its subsidiaries are together referred to in these financial statements as "the Group" or "the consolidated entity".

Subsidiaries

The Group financial statements consolidate those of the parent entity and all of its subsidiary undertakings drawn up to 30 June 2024. Subsidiaries are all entities (including structured entities) over which the Group has:

- (i) The power to direct the relevant activities;
- (ii) Exposure to significant variable returns; and
- (iii) The ability to utilise power to affect the Group's own returns.

Subsidiaries are fully consolidated from the date on which control is fully transferred to the Group. They are deconsolidated from the date that control ceases. All subsidiaries have a reporting date of 30 June.

A list of controlled entities is contained in Note 17 to the Financial Statements.

All transactions and balances between Group companies are eliminated on consolidation, including unrealised gains and losses on transactions between Group companies. Where unrealised losses on intra-group asset sales are reversed on consolidation, the underlying asset is also tested for impairment from a Group perspective. Amounts reported in the financial statements of subsidiaries have been adjusted, where necessary, to ensure consistency with the accounting policies adopted by the Group.

Joint ventures

Joint ventures are accounted for under the equity method. Joint ventures are entities in which the Company exercises joint control by virtue of a contractual agreement.

Under the equity method, on initial recognition the investment in an associate or joint venture is recognised at cost, and the carrying amount is increased or decreased to recognise the investor's share of the profit and loss of the investee after the date of acquisition.

b) Parent Entity Information

In accordance with the Corporations Act 2001, these financial statements present the results of the consolidated entity only. Supplementary information about the parent entity is disclosed in Note 23. The financial information of the parent entity has been prepared on the same basis as the consolidated financial statements, other than investments in controlled entities which are carried at cost less impairment.

c) Operating Segments

An operating segment is a component of an entity that engages in business activities from which it may earn revenues and incur expenses (including revenues and expenses relating to transactions with other components of the same entity), whose operating results are regularly reviewed by the entity's chief operating decision maker (CODM) to make decisions about resources to be allocated to the segment and assess its performance and for which discrete financial information is available. This includes start-up operations which are yet to earn revenues. Management will also consider other factors in determining operating segments such as the existence of a line manager and the level of segment information presented to the Board of Directors.

Operating segments have been identified based on the information provided to the chief operating decision makers — being the Board. The Group aggregates two or more operating segments when they have similar economic characteristics, and the segments are similar in the nature of the minerals targeted. Operating segments that meet the quantitative criteria, as prescribed by AASB 8 Operating Segments, are reported separately. However, an operating segment that does not meet the quantitative criteria is still reported separately where information about the segment would be useful to users of the financial statements.

The Directors have considered the requirements of AASB 8 Operating Segments and the internal reports that are reviewed by the Board in allocating resources have concluded that at this time there are no separately identifiable segments.

d) Finance Income and Expense

Finance income comprises interest income on funds invested, gains on disposal of financial assets and changes in fair value of financial assets held at fair value through profit or loss.

Interest income is recognised as it accrues in the profit or loss, using the effective interest rate method.

e) Plant and Equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment losses. Historical cost includes expenditure that is directly attributable to the items. Repairs and maintenance are charged to the profit or loss during the reporting period in which they were incurred.

Plant and equipment under construction is accumulated until it is installed and ready for use at which time the costs are transferred to plant and equipment and depreciated.

 $\label{lem:preciation} \mbox{Depreciation is calculated using the diminishing value method to allocate asset costs over their estimated useful lives, as follows:$

Plant and equipment 3-20 years

The assets residual values and useful lives are reviewed and adjusted at the end of each reporting period. An asset's carrying amount is written down immediately to its recoverable amount if its carrying amount is greater than its estimated recoverable amount. Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in the profit or loss.

f) Exploration and Evaluation Expenditure

Exploration and evaluation expenditure incurred is accumulated in respect of each identifiable area of interest. These costs are only carried forward to the extent that right of tenure is current, and those costs are expected to be recouped through the successful development of the area (or, alternatively by its sale) or where activities in the area have not yet reached a stage which permits reasonable assessment of the existence of economically recoverable reserves and operations in relation to the area are continuing.

Accumulated costs, in relation to an abandoned area, are written off in full against profit in the period in which the decision to abandon the area is made.

g) Development Expenditure

Development expenditure represents the accumulation of all acquired exploration, evaluation and development expenditure incurred by or on behalf of the entity in relation to areas of interest being prepared for mining or in which economic processing of a mineral reserve has commenced. Amortisation of costs is provided on the unit of production method, with separate calculations being made for each mineral resource. The unit of production basis results in an amortisation charge proportional to the depletion of the economically recoverable mineral reserves. The net carrying value is reviewed regularly and, to the extent to which this value exceeds its recoverable amount that excess is fully provided against in the financial year in which this is determined.

When production commences, the accumulated costs for the relevant area of interest are amortised over the life of the area according to the rate of depletion of the economically recoverable reserves. A regular review is undertaken of each area of interest to determine the appropriateness of continuing to carry forward costs in relation to that area of interest.

The Group records the present value of the estimated cost of legal and constructive obligations (such as those under the consolidated entity's Environmental Policy) to restore operating locations in the period in which the obligation is incurred. Site restoration costs include the dismantling and removal of plant and equipment, waste removal and rehabilitation of the site in accordance with clauses of the mining permits. Such costs have been determined using estimates of future costs and current legal requirements and technology.

Any changes in the estimates for the costs are accounted on a prospective basis. In determining the costs of site restoration, there is uncertainty regarding the nature and extent of the restoration due to community expectations and future legislation. Accordingly, the costs have been determined on the basis that the restoration will be completed within one year of abandoning the site.

h) Financial Instruments

Initial recognition and measurement

Financial assets and financial liabilities are recognised when the entity becomes a party to the provisions to the instrument. For financial assets, this is equivalent to the date that the Group commits itself to either the purchase or sale of the asset.

Financial instruments are initially measured at fair value plus transaction costs, except where the instrument is classified as 'fair value through profit and loss', in which case the costs are expensed to the profit or loss immediately.

Classification and subsequent measurement

Financial instruments are subsequently measured at either fair value or amortised cost using the effective interest method. Fair value represents the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Where available, quoted prices in an active market are used to determine fair value.

The Group does not designate any interest in subsidiaries as being subject to the requirements of accounting standards specifically applicable to financial instruments.

- Financial assets at fair value through profit or loss (equity investments)
 - Financial assets at fair value through profit or loss include financial assets held for trading, e.g., financial assets designated upon initial recognition at fair value through profit or loss, e.g., debt or equity instruments, or financial assets mandatorily required to be measured at fair value, i.e., where they fail the SPPI test. Financial assets are classified as held for trading if they are acquired for the purpose of selling or repurchasing in the near term. Financial assets with cash flows that do not pass the SPPI test are required to be classified and measured at fair value through profit or loss, irrespective of the business model. Notwithstanding the criteria for debt instruments to be classified at amortised cost or at fair value through other comprehensive income, as described above, debt instruments may be designated at fair value through profit or loss on initial recognition if doing so eliminates, or significantly reduces, an accounting mismatch.
- Financial liabilities

Non-derivative financial liabilities are subsequently measured at amortised cost.

Impairment

The Group recognises a loss allowance for expected credit losses on financial assets which are either measured at amortised cost or fair value through other comprehensive income. The measurement of the loss allowance depends upon the group's assessment at the end of each reporting period as to whether the financial instrument's credit risk has increased significantly since initial recognition, based on reasonable and supportable information that is available, without undue cost or effort to obtain.

Where there has not been a significant increase in exposure to credit risk since initial recognition, a 12-month expected credit loss allowance is estimated. This represents a portion of the asset's lifetime expected credit losses that is attributable to a default event that is possible within the next 12 months. Where a financial asset has become credit impaired or where it is determined that credit risk has increased significantly, the loss allowance is based on the asset's lifetime expected credit losses. The amount of expected credit loss recognised is measured on the basis of the probability weighted present value of anticipated cash shortfalls over the life of the instrument discounted at the original effective interest rate.

For financial assets mandatorily measured at fair value through other comprehensive income, the loss allowance is recognised in other comprehensive income with a corresponding expense through profit or loss. In all other cases, the loss allowance reduces the asset's carrying value with a corresponding expense through profit or loss.

i) Impairment of Assets

At each reporting date, the Group reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to profit or loss.

Where it is not probable to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

j) Trade and Other Receivables

Trade and other receivables are initially recognised at fair value and subsequently carried at amortised cost using the effective interest method, less allowances for expected credit losses.

k) Trade and Other Payables

Trade and other payables represent liabilities for goods and services provided to the Group prior to the end of the reporting period which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition. Due to their short-term nature they are measured at amortised cost and are not discounted.

Income Tax

The income tax expense or benefit for the period is the tax payable on that period's taxable income based on the applicable income tax rate for each jurisdiction, adjusted by changes in deferred tax assets and liabilities attributable to temporary differences, unused tax losses and the adjustment recognised for prior periods, where applicable.

Deferred tax assets and liabilities are recognised for temporary differences at the tax rates expected to apply when the assets are recovered, or liabilities are settled, based on those tax rates that are enacted or substantively enacted, except for:

- When the deferred income tax asset or liability arises from the initial recognition of goodwill or an asset or liability in a
 transaction that is not a business combination and that, at the time of the transaction, affects neither the accounting nor
 taxable profits; or
- When the taxable temporary difference is associated with investments in subsidiaries or associates and the timing of the reversal can be controlled, and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred tax assets are recognised for deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

The carrying amount of recognised and unrecognised deferred tax assets are reviewed each reporting date. Deferred tax assets recognised are reduced to the extent that it is no longer probable that future taxable profits will be available for the carrying amount to be recovered. Previously unrecognised deferred tax assets are recognised to the extent that it is probable that there are future taxable profits available to recover the asset.

Deferred tax assets and liabilities are offset only where there is a legally enforceable right to offset current tax assets against current tax liabilities and deferred tax assets against deferred tax liabilities; and they relate to the same taxable authority on either the same taxable entity or different taxable entity's which intend to settle simultaneously.

To the extent that research and development costs are eligible under the "Research and development tax incentive" programme, a 43.5% refundable tax offset is available for companies with annual turnover of less than \$20 million. The Group recognises refundable tax offsets received in the financial year as Other income, in profit or loss.

Tax consolidation

Quantum Graphite Limited (the 'head entity') and its wholly-owned Australian subsidiaries have formed an income tax consolidated group under the tax consolidation regime. The head entity and the subsidiary in the tax consolidated group continue to account for their own current and deferred tax amounts. The tax consolidated group has applied the 'separate taxpayer within group' approach in determining the appropriate amount of taxes to allocate to members of the tax consolidated group.

In addition to its own current and deferred tax amounts, the head entity also recognises the current tax liabilities (or assets) and the deferred tax assets arising from unused tax losses and unused tax credits assumed from each subsidiary in the tax consolidated group.

Assets or liabilities arising under tax funding agreements with the tax consolidated entities are recognised as amounts receivable from or payable to other entities in the tax consolidated group. The tax funding arrangement ensures that the intercompany charge equals the current tax liability or benefit of each tax consolidated group member, resulting in neither a contribution by the head entity to the subsidiaries nor a distribution by the subsidiaries to the head entity.

m) Borrowings

Loans and borrowings are initially recognised at the fair value of the consideration received, net of transaction costs. They are subsequently measured at amortised cost using the effective interest method.

n) Earnings Per Share

Basic earnings per share

Basic earnings per share is calculated by dividing the profit attributable to equity holders of the Group, excluding costs of servicing equity other than ordinary shares, by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year.

Diluted earnings per share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account the after-tax effect and other financing costs associated with dilutive potential ordinary shares and the weighted average number of additional ordinary shares that would have been outstanding assuming the conversion of all dilutive potential ordinary shares.

o) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

p) Share-based Payments

The Company operates equity-settled based remuneration plans for its directors. None of the Company plans features any options for a cash settlement.

All goods and services received in exchange for the grant of any share-based payment are measured at their fair values. Where employees are rewarded using share-based payments, the fair values of employee' services are determined indirectly by reference to the fair value of the equity instruments granted. The fair value is appraised at the grant dates and excludes the impact of non-market vesting conditions (for example profitability and sales growth targets and performance conditions.

All share-based remuneration is ultimately recognised as an expense in profit or loss with a corresponding credit to share option reserve. If vesting periods or other vesting conditions apply, the expense is allocated over the vesting period, based on the best available estimate of the number of share options expected to vest.

Non-market vesting conditions are included in assumptions about the number of options that are expected to become exercisable. Estimated are subsequently revised if there is any indication that the number of share options expected to vest differs from previous estimates. Any cumulative adjustment prior to vesting is recognised in the current period. Non-adjustment is made to any expense recognised in prior periods if share options ultimately exercised are different to that estimated on vesting.

Upon exercise of share options, the proceeds received net of any directly attributable transaction costs are allocated to share capital.

When the share options are forfeited or cancelled after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share options reserve will continue to be held in share options reserve.

q) Employee Benefits

The Group provides post-employment benefits through various defined contribution plans. A defined contribution plan is a superannuation plan under which the Group pays fixed contributions into an independent entity. The Group has no legal or constructive obligations to pay further contributions after its payment of the fixed contribution. The Group contributes to several plans and insurances for individual employees that are considered defined contribution plans. Contributions to the plans are recognised as an expense in the period that relevant employee services are received.

Employee benefits, including annual leave entitlement, are included in 'employee provisions', measured at the undiscounted amount that the Group expects to pay as a result of the unused entitlement.

r) Goods and Services Tax ("GST")

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the ATO. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented in the statement of cash flows on a gross basis, except for the GST components of investing and financing activities, which are disclosed as operating cash flows.

s) Rounding of Amounts

The Group is of a kind referred to in Corporations Instrument 2016/191, issued by the Australian Securities and Investments Commission, relating to 'rounding-off'. Amounts in this report have been rounded off in accordance with that Corporations Instrument to the nearest dollar.

t) Critical Accounting Estimates and Judgements

The Directors evaluate estimates and judgements incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends of economic data, obtained both externally and within the Group.

Key Estimates

Impairment

The Group assesses impairment at each reporting date by evaluating conditions specific to the Group that may lead to impairment of assets. Where an impairment trigger exists, the recoverable amount of the asset is determined.

Decommissioning provision

Estimates and assumptions of the appropriate discount rate at which to discount the liability, the timing of cash flows, the application of relevant environmental legislation and the future expected costs of decommissioning are all used in determining the carrying value of the decommissioning provision. The carrying amount of the provision is set out in Note 13.

R&D Tax Concession

To the extent that research and development costs are eligible under the 'Research and development tax incentive' programme, a 43.5% refundable offset is available for companies with annual turnover of less than \$20 million. Research and development tax incentive income is recognised at fair value when there is a reasonable expectation that the income will be received. The expected future R&D tax incentive for qualifying R&D expenditure has been accrued and is also recognised as other income in the statement of profit or loss. The Company has estimated the amount of future R&D incentive receivable on ongoing projects on the basis that the expected amount of the incentive can be reliably measured and receipted.

Key Judgements

Development expenditure and plant and equipment

The future recoverability of fixed assets and capitalised development expenditure has been assessed by the Directors and is dependent on a number of factors, including commodity prices, the level of reserves and resources, foreign currency rates and future technological changes that could impact the costs of mining and processing and future legal changes. Significant judgements and assumptions are required in making assessments regarding the presence of impairment indicators. This is particularly so in the assessment of long-life assets.

After assessing external and internal sources for the presence of impairment indicators for the Uley Graphite project, no impairment triggers were identified and therefore impairment testing was not required at the reporting date.

Exploration and evaluation expenditure

The future recoverability of capitalised exploration and evaluation expenditure is dependent on a number of factors, including whether the Group decides to exploit the related lease itself or, if not, whether it successfully recovers the related exploration and evaluation asset through sale. Factors that could impact the future recoverability include the level of reserves and resources, future technological changes, which could impact the cost of mining, future legal changes (including changes to environmental restoration obligations) and changes to commodity prices.

To the extent that capitalised exploration and evaluation expenditure is determined not to be recoverable in the future, profits and net assets will be reduced in the period in which this determination is made.

In addition, exploration and evaluation expenditure is capitalised if activities in the area of interest have not yet reached a stage that permits a reasonable assessment of the existence or otherwise of economically recoverable reserves. To the extent it is determined in the future that this capitalised expenditure should be written off, profits and net assets will be reduced in the period in which this determination is made.

Share-based payment transactions

The Group measures the cost of equity-settled transactions with management and other parties by reference to the fair value of the equity instruments at the date at which they are granted. The fair value is determined by the Board of Directors with reference to quoted market prices or using the Black-Scholes valuation method or the Monte Carlo valuation method as appropriate taking into account the terms and conditions upon which the equity instruments were granted. The assumptions in relation to the valuation of the equity instruments are detailed in Note 21. The accounting estimates and assumptions relating to equity-settled share-based payments would have no impact on the carrying amounts of assets and liabilities within the next annual reporting period but may impact expenses and equity.

u) Accounting standards issued but not yet effective and not adopted early by the Group

Australian Accounting Standards and Interpretations that have recently been issued or amended but are not yet mandatory, have not been early adopted by the Group for the annual reporting period ended 30 June 2024. The Group has not yet assessed the impact of these new or amended Accounting Standards and Interpretations.

For the purposes of assessing impairment, the Group's assets are grouped and reviewed for impairment at the CGU level (determined by management as equivalent to its operating segments). The Group has determined that it has a single cash-generating unit (CGU) represented by the Uley 2 Project. Accordingly, the associated plant and equipment, development assets, and exploration and evaluation assets ("the Uley 2 Assets") have been allocated to the CGU.

The Group considers both qualitative and quantitative factors when determining whether an asset or CGU may be impaired. The Directors have reviewed the carrying value and recoverable amount of the Uley 2 Assets and included in their assessment the results of the DFS Update (2023 DFS) that followed the release of the Value Engineering Assessment (VEA) in November 2023.

The VEA was prepared as part of the Company's plans to maximise production to meet the forecast increase in demand for natural flake products by the end of 2025. It resulted in a revision of both the capital and operating costs as at the end of Q2 2023 (2023 Costs Estimate) which were then incorporated in the 2023 DFS published by the Company in December 2023.

The 2023 Costs Estimate was prepared:

Financial Risk Management Policy

The Group's activities expose it to a variety of financial risks: market risk (including interest rate risk), credit risk and liquidity risk. The Risk management is carried out by the Executive Director under policies approved by the Board of Directors. The Board provides written principles for overall risk management, as well as policies covering specific areas, such as interest rate and credit risk. The Group's overall risk management program focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the financial performance of the Group. The Group uses different methods to measure different types of risk to which it is exposed. These methods include sensitivity analysis in the case of interest rate and ageing analysis for credit risk.

a) Liquidity risk

Liquidity risk arises from the possibility that the Group might encounter difficulty in settling its debts or otherwise meeting its obligations related to financial liabilities.

The Group manages liquidity risk by monitoring forecast cash flows and ensuring that adequate working capital is maintained for the coming months. Upcoming capital needs and the timing of equity and debt raisings are assessed by the Board. Financial liabilities are expected to be settled within 12 months.

b) Interest rate risk

Financial assets

The Group's exposure to interest rate risk is the risk that a financial instrument's value will fluctuate as a result of changes in market interest rates. Cash is the only asset affected by interest rate risk as cash is the Group's only financial asset exposed to fluctuating interest rates. The Group is exposed to interest rate risk on cash balances and term deposits held in interest bearing accounts. The Board constantly monitors its interest rate exposure and attempts to maximise interest income by using a mixture of fixed and variable interest rates, whilst ensuring sufficient funds are available for the Group's operating activities. The Group's net exposure to interest rate risk at 30 June 2024 approximates the value of cash and cash equivalents.

Financial liabilities

As at 30 June 2024, the Group has a fixed interest rate of 11.75% p.a. on its unsecured borrowings of \$4,208,345 (2023: \$1,300,434) from a related party. The Group does not have any variable rate borrowings as at the balance sheet date.

c) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in financial loss to the Group. The Group has a strict code of credit, including confirming references and setting appropriate credit limits. The Group obtains guarantees where appropriate to mitigate credit risk. The maximum exposure to credit risk at the reporting date to recognised financial assets is \$2,126,872 (2023: \$1,412,289) as disclosed in Notes 7 and 8 to the financial statements. The Group does not hold any collateral.

Assessment of carrying value of Development Assets Refer to Note 10 in the financial statements

As at 30 June 2024, the Group's Development assets relating to Uley Project ('the Project') had a carrying amount of \$16,027,608.

As required by AASB 136 *Impairment of Assets* ('AASB 136'), management performed an impairment test which entailed:

- Calculating the recoverable amount of the cash generating unit ('CGU') being the Project, which was determined to be the value-in-use of the Project, using a discounted cash flow model: and
- Comparing the resulting value-in-use of the Project to the carrying amount.

We determined this to be a Key Audit Matter due to the significance of these assets in the statement of financial position (71% of the total assets of the Group).

In addition, the directors' assessment of the recoverable amount of these assets involves significant management judgement about the future underlying cash flows relating to the Project and the discount rates applied to them. Our audit procedures in relation to the assessment of carrying value of the Project included:

- Gathering an understanding of the status of the Development assets through discussions with management, review of the ASX announcements and other available information:
- Reviewing the value-in-use calculations used by the
 directors to determine the recoverable value of the
 Project. This procedure included reviewing the
 mathematical accuracy of the value-in-use model,
 comparing and reconciling input data to supporting
 evidence and challenging the reasonableness of
 key assumptions adopted, such as cash flow
 projections, plant utilisation and resource availability,
 future revenue growth rates, discount rates and

- Reviewing management's sensitivity analysis over the key assumptions in the model and assessing whether the assumptions have been applied on a consistent basis across each scenario; and
- Assessing the disclosures in Note 10 to the financial statements to assess compliance with the disclosure requirements of AASB 136.

How our audit addressed this matter

Assessment of Going Concern

Refer to Note 1 in the financial statements

The Group incurred a loss of \$4,368,833 and had net cash outflows from operating activities of \$1,391,216 for the year ended 30 June 2024. As at 30 June 2024, the Group's current liabilities exceeded its current assets by \$1,089,876.

The directors have prepared the financial report on the going concern basis. The directors' assessment of the Group's ability to continue as a going concern is based on a cash flow forecast, which includes extended repayment terms of a credit facility deed with a related party, and the settlement of existing liabilities as at 30 June 2024 by way of issue of shares.

We determined this assessment of going concern to be a key audit matter due to the significant judgements involved in preparing the cash flow forecast, and the potential material impact of the results of management's assessment. Our audit procedures included, among others:

- Reviewing the current financial position of the Group;
- Critically assessing the directors' reasons as to why they believe it is appropriate to prepare the financial report on a going concern basis;
- Assessing the appropriateness and mathematical accuracy of the cash flow forecasts and budgets prepared by management and performing sensitivity testing on these assumptions;
- Reviewing the terms and conditions of the amended credit facility deed from the related party, to confirm additional loans advanced and extension of the repayment terms;
- Conducting subsequent event testing to corroborate the repayment of existing liabilities as at 30 June 2024 by way of issue of shares; and
- Assessing the adequacy of the going concern disclosures in the financial report.
