ACQUISITION OF URANIUM PROJECTS IN SA

Heavy Rare Earths Limited ("**HRE**" or "**the Company**") refers to its announcement dated 21 October 2024 titled "Acquisition of Three Highly Prospective Uranium Projects in South Australia" ("**Transaction**").

Unless otherwise stated, capitalised terms in this announcement have the meaning given to them in the Transaction announcement.

An updated indicative timetable with respect to the Transaction is set out below.

Under the updated timetable, investors who participate in the Tranche 1 Placement will now be able to participate in the fully Underwritten Entitlement Offer. As a consequence, the Company will now raise \$1.26 million under the Entitlement Offer with the additional funds (of \$240,000) being used for working capital purposes.
