Traffic Technologies amends timetable for Entitlement Offer

Traffic Technologies Ltd (ASX: TTI) ('Traffic Technologies' or the Company) refers to its prospectus lodged with ASIC and ASX on 11 November 2024 earlier today (**Original Prospectus**) regarding the pro-rata non-renounceable entitlement offer of one (1) new Share for every two (2) Shares held by Eligible Shareholders registered at the Record Date at an issue price of \$0.005 (0.5 cents) per Share, along with one (1) free attaching Option for every new Share issued under the offer (**Entitlement Offer**).

As a consequence of not lodging the ASX Appendix 3B in relation to the Offer before market open today, the Company has amended the indicative timetable for the Entitlement Offer as included in the Original Prospectus by deferring the Ex-date, the Record Date and the Offer Opening Date, in each case, by 1 business day.
