## **Notice of Second Court Hearing**

Capitol Health Limited ACN 117 391 812 (ASX: CAJ) (**Capitol**) provides the following update in relation to the proposed merger with Integral Diagnostics Limited (ASX: IDX) (**Integral**) by way of a scheme of arrangement (**Scheme**).

Subject to Capitol Shareholders approving the Scheme by the requisite majorities at the Scheme Meeting to be held on 2 December 2024, on **Wednesday**, 4 **December 2024 at 2.15pm** at 305 William Street, Melbourne VIC 3000, the Federal Court of Australia (Victoria Registry) will hear an application by Capitol seeking the approval of the Scheme (**Second Court Hearing**).
