# **Expiry of Listed Options (ASX Code ALROB)**

Altair Minerals Limited (ASX: ALR) ('Altair or 'the Company') advises that 462,791,693 ALROB Listed Options, exercisable at \$0.01 (1 cent) (**ALROB Options**) will expire at 5.00pm (AEDT) on Monday, 30 December 2024 (**Expiry Date**).

Official quotation of the Options on ASX will cease at close of trading on Friday, 20 December 2024, being four business days before the Expiry Date.

The Company notes that the Options are substantially "out of the money" and as such the Company will not be dispatching personalised notices to option holders in accordance with Item 5.3 of Appendix 6A to the Listing Rules.

In accordance with Item 5.2 of Appendix 6A, the Company provides the following information to holders of the Options:

- 1. the total number of ALROB Options on issue is 462,791,693;
- 2. the number of fully paid ordinary shares in the Company to be issued on the exercise and conversion of the ALROB Options is 462,791,693;
- 3. the exercise price for each ALROB Option is \$0.01 (1 cent);
- 4. the due date for payment of the exercise price (in cleared funds) is the Expiry Date;
- 5. if payment in cleared funds is not received by the Expiry Date, the Options will expire unexercised and all rights attaching to the Options will cease;
