

ASX Announcement | 4 December 2024 DomaCom Limited (ASX: DCL)

Response to Recent Media Articles and Allegations

DomaCom Limited (ASX:DCL) ('**DomaCom**' or '**Company**') refers to claims made in a recently published article (under the title "Battle looms over future of DomaCom's NDIS housing funds") by the Australian Financial Review on 2 December 2024. The article raises concerns about the Company's financial position and makes speculative claims about the performance and future of certain sub-funds on the DomaCom platform. DomaCom strongly refutes these allegations and reaffirms its unwavering commitment to Unit Holders.

Financial Stability and Progress

Assertions that DomaCom is in a "precarious financial position" are without merit. As outlined in our ASX announcement on 18 November 2024, the Company has secured fresh financial commitments, which have significantly bolstered our financial stability. Additionally, a member resolution passed on 25 November 2024 enables DomaCom to issue up to 400,000,000 shares, providing a solid foundation for further capitalisation and sustainable growth.

DomaCom remains confident in its financial outlook and its leadership team's ability to deliver on its strategic objectives, ensuring value creation for all stakeholders.

Commitment to Sub-Fund Performance and Unit Holder Engagement

While challenges persist in certain NDIS sub-funds, DomaCom remains steadfast in its "fund-first" vision, prioritising transparency, active communication with Unit Holders, and the implementation of strategies to restore sub-fund value.

We assure Unit Holders that underperforming sub-funds are being actively managed with their best interests at heart. Our focus remains on collaborating with Unit Holders to identify and execute solutions that drive optimal outcomes.

Clarification on Third-Party Actions and Misleading Claims

Recent statements suggesting that the only viable pathway for Unit Holders to ensure current investment strategies are maintained, or for the possibility of investments returns is to move to BrickX are misleading and inaccurate. Any decision regarding changes to investment strategies will remain firmly in the



hands of Unit Holders, guided by DomaCom's commitment to protecting their interests.

DomaCom's Commitment to Stakeholders

DomaCom is dedicated to delivering long-term value for investors, maintaining the integrity of its platform, and safeguarding the performance and stability of its sub-funds. We continue to work closely with the Trustee to address challenges and ensure the Company operates in alignment with the highest standards of transparency and governance.

We take these allegations seriously and remain proactive in engaging with Unit Holders to address their concerns and reaffirm confidence in DomaCom's operations.

Further Actions

DomaCom is actively monitoring the situation and stands ready to take appropriate steps to protect its reputation and the interests of its Unit Holders. As always, the Company will disclose any material developments to the market in line with its continuous disclosure obligations.

DomaCom remains committed to a future of sustainable growth and positive outcomes for all stakeholders.
