Net Tangible Asset Backing 30 November 2024

Diversified United Investment Limited (ASX: DUI) advises that the unaudited Net Tangible Asset backing of the Company's ordinary shares at 30 November 2024 was \$6.25 per share (31 October 2024: \$6.03 per share).

The Net Tangible Asset backing calculation is based on investments at market value, is after tax on net realised gains, before any future tax benefit of net realised losses and before estimated tax on net unrealised gains/losses.

DUI is a long-term investor and does not intend disposing of its total portfolio. However, under current accounting standards the Company is required to provide for estimated tax on any net gains that would arise on such a theoretical disposal. After deducting this provision, the above figure would be \$5.09 (31 October 2024: \$4.94).

At 30 November 2024:

- International equities funds comprised 19.9% of the portfolio;
- Available bank facilities were \$82.5M, fully undrawn;
- Cash and net short-term receivables were \$16.2M.
