ASX Announcement

Results of Unmarketable Parcels Share Buy Back

Adacel Technologies Limited (**Adacel** or the **Company**) is pleased to announce that it has completed the Unmarketable Parcels Share Buy Back as announced to the ASX on 23 October 2024. The Company offered the Unmarketable Parcel Buy-Back to shareholders holding less than a marketable parcel of Adacel shares as at the Record Date (Eligible Shareholders).

The Company provided the Unmarketable Parcel Buy-Back to Eligible Shareholders to facilitate the sale of their shares without incurring any brokerage or handling costs at a price of \$0.50 per Share (Buy-Back Price), being a 6% premium to the 5 day volume weighted average price (VWAP) of Shares at the close of trade on the Record Date. A holding of less than 1041 shares constituted an Unmarketable Parcel of \$500, making 790 shareholders eligible to participate in the Unmarketable Parcel Buy-back.

The final number of shares bought back under the Unmarketable Parcel Buy-back was 385,128 ordinary shares comprising 666 shareholders. The shares bought back under the Unmarketable Parcel Buy-back will cost Adacel approximately A\$192,500. Payment of the proceeds will be dispatched to participating shareholders in the coming days to the bank account registered with the share registry or otherwise by cheque.
