# Change of Auditor

**Melbourne, Australia – Titomic Limited (ASX: TTT)**, the world's leading provider of cold spray solutions, announces that RSM Australia Partners (RSM) has been appointed as the Company's Auditors with effect from 20 December 2024.

The appointment has been formally approved by the Australian Securities & Investment Commission (ASIC) and as part of the transition process a letter of resignation has been received from BDO Audit Pty Ltd (BDO).

The decision to change auditors was made following a review by the Board of the Company's external audit arrangements with consideration given to costs and global capabilities given the Company's planned expansion in the United States of America. The Board undertook a tender process and RSM was selected based on their reputation and experience.

In accordance with section 327C of the Corporations Act 2001, a resolution will be tabled at the Company's 2025 Annual General Meeting to ratify the appointment of RSM as the Company's auditor.
