Sydney, 14 January 2025 — NoviqTech (ASX: NVQ) is pleased to announce the successful completion of all onboarding steps for GRR's sustainability initiatives, facilitated through our Carbon Central platform. This milestone includes the implementation of an ISCC-aligned digital twin and the tokenisation of reclaimed Glycol to create ISCC aligned sustainability declarations, further enhancing transparency and trust in GRR's sustainable recycling operations.

Key Highlights

- **Lifecycle Assessment & Data Review**: Comprehensive data reviews were conducted to ensure that it accurately aligns with the lifecycle assessment requirements prescribed in ISCC standards.
- **Site Visit in Darwin**: Our team finalised assumptions, reviewed data, and scoped ISCC-tracked products during a site visit.
- **Digital Twin Implementation**: A digital twin was finalised, including simulations to verify assumptions of Glycol processing and guarantee of origin.
- Amines Batch Processing Commenced: GRR has newly initiated its amines recycling, which follows a similar process to Glycol and will be tokenised on Carbon Central.
- Improved Data Capture: New flow meters installed at GRR's facilities enhance data precision, boosting trust and transparency.

Next Major Milestone: Mainnet Tokenisation

The next significant step will involve migrating Glycol and Amines to mainnet tokenisation where a fee will be charged per each token produced. Mainnet tokens will then be used to generate ISCC aligned sustainability declarations for GRR. This transition will further solidify the digital provenance of these recycled products and enhance their marketability as verified sustainable resources.
