# Southern Cross Gold Consolidated Ltd (ASX: SX2) (previously known as Mawson Gold Limited) – Admission and Quotation, Deferred Settlement Trading

#### **Description**

Southern Cross Gold Consolidated Ltd ('SX2') was admitted to the Official List of ASX on 15 January 2025.

The securities of SX2 will commence quotation at 3:00 PM AEDT on 16 January 2025, initially on a <u>deferred</u> settlement basis.

The shares of SX2 will be settled in the form of CHESS Depositary Interests ('CDIs') at a ratio of 1:1.

Following completion of all necessary conditions to a proposed scheme of arrangement ('Scheme'), SX2 will acquire all of the issued share capital of Southern Cross Gold Limited ('SXG'). Eligible SXG Scheme shareholders that are on the SXG share register on the record date will have their SXG shares acquired in exchange for one SX2 CDI or, if the shareholder has made a valid election, one SX2 common share in book-entry form in the Direct Registration System.

No funds were raised by SX2 in connection with its listing on ASX.
