## **Quarterly Activities Report**

**Q3 FY25 headlines:**

- **Company has paused the hay processing activity at its Epsom site and has reduced costs to preserve cash balance as challenging market conditions persist in key Asian markets; and**
- **Management pursuing transaction opportunities in Agriculture sector.**

Wingara AG Limited (ASX: WNR), the owner and operator of value-add, mid-stream assets specialising in the processing, storage and marketing of agriculture produce for export markets, is pleased to provide this quarter's activities report alongside its Appendix 4C (Quarterly Cashflow Report) for the nine months ended 31 December 2024 (Q3 FY25).

**Commenting on Q3 FY25, Wingara's Managing Director and Chief Executive Officer Marcello Diamante said:**

"As announced to the market in its business update on 14<sup>th</sup> November 2024, processing activities have been paused whilst management focus its activities in providing storage and marketing services. This strategy aims to preserve the cash balance through minimising costs whilst it also reviews market opportunities that align with the Wingara platform. The Company will provide further information to the market on these opportunities as they arise".

Challenging market conditions continue to persist in key Asian markets. Export prices for oaten hay this season continue to be weighed down and the expectation is that demand will not improve in the early part of 2025.

In light of the continued trading conditions, further cost reductions have been implemented across Q3 FY25 in both operational and corporate aspects of the Company.

Current cash and cash equivalents as at 31 December 2024 was \$613k with a focus on cost control and managing its remaining liabilities whilst management utilises and reviews its assets to maximise cash generation opportunities.

In accordance with ASX Listing Rule 4.7C.3, payments to related parties and their associates outlined in the Company's Appendix 4C for the quarter relate to fees and salaries paid to Directors.
