Wellnex Life Limited - Non-Renounceable Entitlement Offer

If you take up your full Entitlement, you may also apply for additional New Shares in excess of your Entitlement under the Shortfall Offer.

New Shares issued under the Entitlement Offer will rank equally with Existing Shares on issue. Fractional entitlements will be rounded up to the nearest whole number of New Shares.
