**Smart Parking Ltd (ASX: SPZ) Entitlement Offer cleansing notice under 708A(5)(e) of the Corporations Act 2001(Cth)**

This notice (this **Notice**) is given by Smart Parking Limited (ACN 119 327 169) (ASX:SPZ) (the **Company** or **Smart Parking**) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (the **Corporations Act**).

The Company refers to its announcement on Monday, 17 February 2025 regarding the entry into a binding agreement dated 17 February 2025 (**Equity Acquisition Agreement**) to acquire 100% of the issued capital in Peak Parking LP (**Peak Parking**) for the acquisition price of up to USD\$36.0m (**US Acquisition**) consisting of upfront consideration of USD\$32.0m payable in USD\$26.0m in cash and USD\$6.0m worth of fully paid ordinary shares in Smart Parking to the sellers of Peak Parking (**New Shares**).

On Friday, 28 February 2025, the Company issued 9,725,307 New Shares to the sellers of Peak Parking on closing of the US Acquisition as part consideration for the US Acquisition in accordance with the Equity Acquisition Agreement (**Consideration Shares**). The Company has issued the Consideration Shares pursuant to the Company's available capacity under ASX Listing Rule 7.1.

The Consideration Shares are subject to a period of voluntary escrow of 12 months for their date of issue, being 2 March 2026.

The Company advises that:

- a) the Consideration Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act 2001;
