Answer: No, as result of the lease entered into in April 2025, the company expects increased revenues and margins from its Chilean operations

Answer:

On 23 April 2025, the company announced that it entered into a long term lease on a 2nd site in Chile. This will allow the company to significantly scale up its processing of construction materials. It will also result in increased margins as a result of reduced transport and power costs.

On 23 April 2025, the company also announced that it completed a non-brokered placement raising \$700,000 before costs.

On 23 April 2025, the company also announced that it will undertake an entitlement offer that will raise up to a further \$513,088 before costs.
