

# Results of Scheme Meeting – Dropsuite Shareholders vote in favour of Scheme of Arrangement

**9 May 2025:** Dropsuite Limited (ASX:DSE) ("**Dropsuite**" or the "**Company**") is pleased to announce that Dropsuite shareholders have today approved the proposed acquisition of Dropsuite by NinjaOne Australia Pty Ltd by way of scheme of arrangement ("**Scheme**").

#### **Results of the Scheme Meeting**

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the *Corporations Act 2001* (Cth), Dropsuite advises that the resolution to approve the Scheme ("Scheme Resolution"), as set out in the Notice of Scheme Meeting included in the Scheme Booklet dated 2 April 2025 ("Scheme Booklet"), was passed by the Requisite Majorities of Dropsuite shareholders at the Scheme Meeting held earlier today.

#### In summary:

- 99.95% of the votes cast by Dropsuite shareholders were in favour of the Scheme Resolution; and
- 96.8% of Dropsuite shareholders present and voting at the Scheme Meeting (either in person or by proxy, attorney or corporate representative) were in favour of the Scheme Resolution.

Details of the valid proxies received, and votes cast at the Scheme Meeting are set out at the end of this announcement.

#### **Next steps**

The Scheme remains subject to the approval of the Court at the Second Court Hearing scheduled for 10.15am (Melbourne time) on Wednesday, 14 May 2025, and certain other conditions precedent described in the Scheme Booklet. Details regarding the Second Court Hearing are set out in Dropsuite's ASX announcement dated 5 May 2025.

If the outstanding conditions precedent are satisfied or waived (if applicable) prior to the Second Court Hearing, and the Court approves the Scheme, Dropsuite proposes to lodge a copy of the orders of the Court with the Australian Securities and Investments Commission (which is expected to occur on Wednesday, 14 May 2025) ("Effective Date"), at which time the Scheme will become legally effective. It is then expected that:

- Dropsuite shares will be suspended from trading on the ASX from the close of trading on the Effective Date; and
- on Friday, 30 May 2025, the Scheme will be implemented and the Scheme Consideration of A\$5.90 cash per Dropsuite Share will be paid to Dropsuite shareholders in respect of all Dropsuite Shares held on the Scheme Record Date, which is expected to be 7.00pm (Melbourne time) on Friday, 16 May 2025.

The above timetable is indicative only and the included times and dates are subject to change. Dropsuite will announce any changes to the ASX.
