TasmaNet sale

Rob Smith and Matthew Hutton, partners of McGrathNicol (**Receivers**), announce that at approximately 10:30 PM (AEST) on 15 May 2025 a binding agreement to sell Field Solutions Group's TasmaNet business and assets (the **Transaction**) was executed with Comms Group Ltd (**CCG**).

The Transaction will result in the transfer of the TasmaNet business and parts of Field Solutions Group's mainland managed services business to CCG on a going concern basis, along with the transfer of 30 Field Solutions Group employees, and is expected to complete within the coming weeks.
