NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

FOS Capital Limited (Company) gives this notice pursuant to Section 708A(5)(e) of the Corporations Act in relation to 967,742 ordinary shares issued on 13 May 2025 for the acquisition of Glowing Structures, 12,333,334 ordinary shares issued on 24 June 2025 (a placement of shares to institutional and sophisticated investors) for the acquisition to fund the acquisition of street lighting business assets (ATS) from Traffic Technologies Ltd group (in Administration) and working capital, and issue of 138,889 ordinary shares on 24 June 2025 to employees as a part of an employee incentive program.
