### Commencement of litigation

23 July 2025, Melbourne

Integral Diagnostics Limited (ASX: IDX) (**Integral**) advises that it has been served with a claim which was filed in the Supreme Court of Queensland by the Vendors of the Imaging Queensland business which Integral acquired in 2019. In the claim the Vendors seek damages and other relief from Integral and a subsidiary of Integral in relation to an earn out valuation dispute.

The Vendors have commenced this proceeding more than two years after an independent expert appointed by the parties determined a valuation for the earn out of \$2.2m. Integral has previously sought to resolve this dispute, based on this valuation. However, the Vendors have declined and have now commenced a proceeding. Integral intends to defend the proceeding. Details of the dispute and Integral's provisioning are disclosed in Integral's Annual Report.
