Trading Update

Increases in Hydrix Services June quarter sales activity and recent contract wins supports near term growth.

Hydrix Limited ('Hydrix' or 'the Company') (ASX: HYD) today released its Appendix 4C for the quarter ended 30 June 2025 (4QFY25) and provides the following **Market Update**.

4th Quarter Financial Highlights

Hydrix Services

- o Stronger June quarter revenues, recent sales wins, increase in sales activity
- \$2.4m of revenues for the quarter (flat YoY) up 10% from the March quarter, primarily in cardiac and medtech products, with emerging growth from defence clients
- 18 contract sales wins to new and existing clients totalling \$3.5m in revenues
- 20 active clients where paid work is currently being undertaken provide \$40.0m potential future project revenue base

Other Group Updates

- o Hydrix Medical is progressing sales opportunities of its remote cardiac monitoring software
- **\$0.3m** cash on hand plus a **\$2.0m** Letter of Comfort from a major shareholder provided in August 2024 (of which **\$0.75m** has been drawn down)
- o \$0.76m operating loss was a 45% improvement to the \$1.4m operating loss in the pcp

Hydrix Executive Chairman, Gavin Coote, commented:

"After a subdued March quarter due to global macro and political factors, Hydrix Services evidenced increased sales activity late in the quarter, and we are encouraged by a range of emerging green shoots.

"The Board see several opportunities to grow the business and to unlock shareholder value, committing working capital to support our forward progress. With recent sales outcomes, we are well placed to build further revenue momentum in the December half."

 - 8.6.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?
 - Answer: No. Hydrix does not expect to continue to have the current level of net operating cash flows. Hydrix anticipates incremental improvements to operating cash flows through the next quarter as a result of cost saving initiatives implemented and higher revenues increasing cash receipts from customers. Customer receipts that are overdue are anticipated to be receipted this quarter as clients progress through fundraising rounds, thereby injecting working capital into the business.
 - 8.6.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?
 - Answer: Yes. A Director and major shareholder provided a \$2.0 million Letter of Comfort to the business through 30 September 2025. During the quarter, approximately \$0.75 million had been drawn down as at 30 June 2025.
 - 8.6.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?
 - Answer: Yes. Based on current trading assumptions, Hydrix expects to be able to continue its operations and meet its business objectives. The Board considers these assumptions to be reasonable based on current information available and continues to monitor these assumptions and the Group's operating performance.
