**IDT Australia Limited – Request for Trading Halt**

IDT Australia Limited (ACN 006 522 970) (ASX: IDT) (“IDT”) requests that an immediate trading halt be granted by the Australian Securities Exchange (“ASX”) relating to a change in management.

In accordance with ASX Listing Rule 17.1, IDT provides the following information:

1. The trading halt is necessary to enable IDT to finalise details of a change in management;
