

### **CEO Transition**

**Lark Distilling Co. Ltd (ASX: LRK)** ("**LARK**" or the "**Company**") Australia's Number 1 Luxury Single Malt Whisky producer and brand today announces a leadership transition, with the appointment of Mr Stuart Gregor as Managing Director and Chief Executive Officer, effective 1 January 2026.

Mr Gregor, a co-founder of Four Pillars Gin and currently a Non-Executive Director of LARK, will succeed Mr Satya (Sash) Sharma, who will step down as CEO on 31 December 2025, following three years of outstanding service to pursue a leadership opportunity with a major global Spirits Industry player.

Incoming MD and CEO, Mr Stuart Gregor, has been a Non-Executive Director of LARK since 2024 and has an intimate understanding and knowledge of the business. Stuart brings a wealth of industry knowledge with over 25 years of experience spanning brand creation, premium drinks marketing and international expansion and entrepreneurial expertise.

Stuart is one of Australia's most accomplished drinks industry leaders, having co-founded Four Pillars Gin in 2013, growing it from a small craft operation into a globally celebrated gin brand. Under his leadership, the brand scaled internationally and was eventually sold to drinks giant Lion (part of Kirin Group), in 2023, which marked one of the most successful exits in the Australian spirits sector.

Beyond entrepreneurship, Stuart has held senior leadership roles in communications and brand strategy, co-founding Liquid Ideas, a leading PR and marketing firm specialising in premium food, beverage, and lifestyle brands. He is also a past President of the Australian Distillers Association, where he played a central role in advocating for the growth and global recognition of Australia's spirits industry.

Stuart's recent Board experience with LARK gives him a strong understanding of governance, strategy, and shareholder value creation. His reputation for innovation, consumer insight and building globally relevant premium brands makes him exceptionally well positioned to lead LARK through its next phase of growth.

"We are excited to have Stuart join as LARK's next MD & CEO. Stuart already has a deep understanding of LARK through his role on our Board and has been intimately involved in the re-stage of our Brand as we embark on our exciting next chapter. "Sash has also been instrumental in driving operational excellence, embedding strong governance, and elevating the Company to its position as Australia's Number 1 Luxury Single Malt. We are delighted he



will remain with LARK until year end, ensuring a seamless transition of leadership. He departs with our gratitude and very best wishes for the future."

"The opportunity to lead LARK is rare and exciting in the Australian distilling landscape and is the only one that would have attracted me back into the industry following the successful sale of Four Pillars to Lion.

"We have Australia's most iconic legacy in Bill and Lyn Lark, and one of the country's finest and most creative distillers in Chris Thomson crafting some of the world's best whiskies. In addition, with the unique access to rare Seppeltsfield casks, our Tasmanian peat marsh and the whisky making super climate that Tasmania offers, we have everything we need to take this brand to new heights. I'm excited to lead LARK and the team for what will be an incredible period ahead."
