PLACEMENT AND CONVERTIBLE NOTE ISSUE

The Board of Stanfield Funds Management Limited (the "Company") announces that it has raised \$135,103 by:

- The issue of up to 319,118 fully paid ordinary shares (Placement Shares) in the Company at an issue price of \$0.11 each. The Company offered Placement Shares (Placement Offer) to a sophisticated investor, Blizzard Winds Pty Ltd, to raise \$35,103. On issue, the Placement Shares will rank equally with the existing ordinary shares on issue.
- A Convertible Note has been successfully negotiated with Quincetree Pty Ltd which will provide the Company with \$100,000. The Note is convertible to shares at \$0.12 per share at Quincetree's election and at each conversion 1:1 options shall be issued exercisable by June 2017 at \$0.15 per share. Interest is payable upon conversion at 15% p.a. from the date of issue to the date of conversion.

The Company intends to use the funds raised under the Placement Offer and Convertible Note for working capital and other growth opportunities. An Appendix 3B follows accordingly.
