

Cleansing notice under section 708A the Corporations Act 2001 (Cth)

For Immediate Release: June 30, 2014

Sydney, Australia – Simavita Limited ("**Simavita**" or the "**Company**") (TSXV: SV; ASX: SVA) advises that it has allotted the 6,886,673 CDIs pursuant to the initial tranche of the private placement, as announced on June 23, 2014 in Australia (June 22, 2014 in Canada), to sophisticated and institutional investors in Australia and the United Kingdom.

The issue of the CDIs at the issue price of AUD\$0.45 per CDI raised a total of AUD\$3,099,003 prior to the payment of associated costs. Further details are provided in the attached ASX Appendix 3B.

The Company gives this Notice under section 708A(5)(e) of the *Corporations Act 2001 (Cth)* (the "Corporations Act").

The CDIs described above were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
