**NEW CHAIRMAN FOR IRESS LIMITED CONFIRMED** 

At IRESS' Annual General Meeting on 1 May 2014, current Chairman, Mr Peter Dunai, announced his

intention to leave the Board of IRESS.

Mr Dunai also announced that the Board of IRESS would appoint current IRESS director Mr Tony D'Aloisio

to become Chairman during 2014 on a date to be confirmed.

Having worked together closely since the AGM to ensure an orderly transition, the Board confirms that Mr

Dunai will hand over the Chairmanship to Mr D'Aloisio effective today.

Mr Dunai will continue as a Director of the Board until following the Board's next meeting, and will retire

effective 30 September 2014.

Mr Peter Dunai founded IRESS with colleagues in 1993 and served as its Managing Director from 2001 until

2009 and subsequently as Chairman. During that time the company grew steadily to become a global

supplier of information, trading, order management and wealth management systems. Listing on the ASX in

2000, the company has been in the S&P/ASX 200 since 2001 with a current market capitalisation of \$1.5

billion.

Mr Dunai said: "I feel fortunate to have been on a shared journey with so many talented and dedicated

colleagues for so many years. I am very confident that our people, management and directors have the skills

and experience to take the company forward.

"Tony has served on the IRESS board for a number of years and is very familiar with the company and its

culture and I am very confident that the company will be in good hands under his chairmanship."

IRESS Chief Executive Officer, Andrew Walsh, said: "Peter's contribution to IRESS has been enormous, but

to see it only historically doesn't do justice to that contribution. The future of the business will be profoundly

influenced for many years by what Peter has helped to create. IRESS' approach to innovation, customer

service and management – its culture, is a reflection of that contribution."
