GREEN INVEST LIMITED - RECAPITALISATION PROPOSAL

Green Invest Limited (**Company**) announced on 28 August 2014 a recapitalisation plan, which included a partially underwritten non-renounceable rights issue (**Rights Issue**) to all eligible shareholders, on the basis of 1 new share for every 1 share held at an issue price of \$0.02 to raise \$1.18 million.

The Company wishes to advise the market that there is a delay in the lodgement of the prospectus in relation to the Rights Issue (**Prospectus**). It is anticipated that the Prospectus will now be lodged with ASX on 29 September 2014.*

Accordingly, the Rights Issue will have a revised record date of 3 October*, and the offer will open to eligible shareholders on 10 October 2014* and close on 10 November 2014*. The table below sets out the updated dates in respect of the Rights Issue process:
