1 Accounts and Reports

To receive and consider the financial statements for the year ended 30 June 2014 together with the related Directors' Report, Directors' Declaration and Audit Report.

There is no requirement for a formal resolution on this item. The Chairman will allow reasonable opportunity to shareholders at the meeting to ask questions about, or make comments on those statements and reports.

2 Board membership limit

The company's Constitution requires that the board comprise between three and seven members.

Section 201P of the Corporations Act 2001 requires that shareholders approve and confirm board membership numbers below the maximum set in the company's Constitution. Directors do not consider, at this stage, that increasing membership of the board to a total of seven members will provide any significant benefit to the company. Nevertheless, this matter will be kept under review and directors may choose to increase the board membership as considered necessary. It should be noted that shareholders must confirm at each subsequent AGM, the total membership number of the board where it remains below the maximum given in the Constitution.

The following is proposed for shareholders to consider, and if thought fit, to pass as an ordinary resolution: That the membership of the board be confirmed to be five directors.

3 Election of directors

The following directors retire in accordance with the company's Constitution and the Australian Securities Exchange Listing Rules, and being eligible, offer themselves for re-election as directors.

The following is proposed for shareholders to consider, and if thought fit, to pass as separate ordinary resolutions:

- (a) Re-elect Mr GD Mulligan as a director.
- (b) Re-elect Mr GW Chalmers as a director.

4 Audited Remuneration Report

To consider and resolve to adopt the Audited Remuneration Report for the year ended 30 June 2014 as detailed in the Annual Report.

Please note that the vote on this resolution is advisory only and does not bind the directors of the company.

5 Other Business

To consider any other business which may be brought forward in accordance with the company's Constitution and the Corporations Act 2001.

Notes: A member who is entitled to attend and vote at the meeting may appoint no more than two proxies to attend and vote in the member's stead. A proxy need not be a member of the company. A Proxy Form is provided on the next page.

If the appointments do not detail the percentage or numbers of votes that each proxy may exercise, then each proxy may exercise half of your total votes. Fractions of votes will be disregarded.
 - (b) Return both the first and second Proxy forms together to the company.
- 2. A proxy need not be a member of the company.
- 3. In order for this Proxy Form to be valid, it must be lodged not less than 48 hours before the commencement of the Annual General Meeting. Lodgement may be made by delivery, post, facsimile, or email to Chalmers Limited.
