Iatia Limited (Iatia or the Company) is pleased to advise that the Company has entered into a Subscription Agreement with MCGG Pty Ltd (MCGG) to issue 177,827,810 ordinary shares in Iatia Ltd in exchange for \$30,000.

The fund will enable Iatia to fully repay all secured creditors and trade creditors, and allows Iatia to continue operations as it evaluates the acquisition of further assets for the benefit of shareholders.

The Subscription Agreement will see MCGG hold 13% of Iatia Ltd.

The Board of Directors, having evaluated the opportunities, are of the opinion that this represents Iatia's best option to obtain funding to meet its current cash requirements and obligations for the longer term benefit of shareholders.
