NET ASSET BACKING

The Directors advise that the unaudited net tangible asset backing of the Company's ordinary shares at 31 October 2014 was \$3.86 per share (30 September \$3.70 per share). The net asset backing calculation is based on investments at market value, is after tax on realised gains, before any future tax benefit of realised losses, and before estimated tax on net unrealised gains/losses.

Diversified United Investment Limited is a long term investor and does not intend disposing of its total portfolio. However, under current accounting standards the Company is required to provide for estimated tax on any net gains that would arise on such a theoretical disposal. After deducting this provision, the above figure would be \$3.31 (30 September 2014 \$3.20).

A list of the Company's top 25 investments is attached.

These figures are prior to the allotment of shares and take up of funds under the 1 for 5 Renounceable Rights Issue, which occurred in November.
